ORDER FOR COMPLIANCE NOTICE OF HEARING TO ASSESS ADMINISTRATIVE FINE

AFTER DUE NOTICE to Respondent(s), the SPECIAL MAGISTRATE OF THE CITY OF NORTH heard testimony and took evidence concerning the above-styled cause at a public hearing on February 26, 2015. Based upon the testimony heard and the evidence presented, the SPECIAL MAGISTRATE established the following FINDINGS OF FACT in this cause:

- Respondent(s), Michael Schoeff, own(s) the property commonly known as, 1668 Tropicalre Blvd., North Port, Sarasota County, Florida (LOT 13 BLK 38 NORTH PORT CHARLOTTE ESTATES 2ND ADD, a subdivision according to Plat thereof, of the Public Records of Sarasota County, Florida).
- 2. Building Department Inspector KYLE HOFFMAN served the Respondent(s) a NOTICE OF ORDINANCE VIOLATION, dated January 26, 2015.
- 3. The Respondent did not comply with the NOTICE OF ORDINANCE VIOLATION within the time frame set forth therein.

Based upon the foregoing FINDINGS OF FACT, the BOARD finds the following CONCLUSION(s) OF LAW:

4. Respondent's actions constitute a violation of:

Section 53-27, Unified Land Development Code - Special Exceptions - AG District

Based upon the FINDINGS OF FACT and CONCLUSION(s) OF LAW, and upon consideration, It is thereupon

ORDERED that:

5. Respondents(s) shall correct the violation(s) by promptly contacting Planning and Zoning at (941.) 429-7156 to file for a special exception for this property.

- 6. If Respondent(s) fall(s) to correct the violation(s) by March 15, 2015, RESPONDENT MAY BE ASSESSED THE SUM OF \$25.00 per day, beginning March 16, 2015, which shall continue to accrue daily until the property is brought into compliance as set forth in Paragraph 5 AND SUCH COMPLIANCE IS CONFIRMED IN ACCORDANCE WITH Section 2-511 (C), Code of the City of North Port, or until the Maximum Cumulative Fine of \$2,000.00 has been reached.
- 7. Respondent(s) shall attend a hearing before the SPECIAL MAGISTRATE scheduled for *March 26, 2015, at 9:00 a.m.* or as soon thereafter as possible, in Room 244, City Hall, 4970 City Hall Boulevard, North Port, Florida for the purpose of determining whether the stated administrative fine should be assessed for fallure to comply with this Order for Compliance.
- 8. A certified copy of an ORDER ASSESSING ADMINISTRATIVE FINE imposing the above stated fine may be recorded in the Public Records of Sarasota County, Florida by the City Clerk of the City of North Port and shall constitute a lien upon the real property on which the violations(s) exists and upon the real or personal property owned by the violator(s) consistent with Chapter 162, Florida Statutes, and Chapter 2, North Port City code, for which let execution issue.
- 9. THE SPECIAL MAGISTRATE retains jurisdiction in all respects to enforce its prior order(s) requiring compliance and to issue such orders having the force of law to command whatever steps are necessary to bring continued violation(s) into compliance.

As soon as compliance is achieved, Respondent shall notify the Property Standards Department IN WRITING to request a re-inspection using the "Request for Re-inspection" form that is attached to this Order. Respondent shall provide the completed form to:

BASED UPON the foregoing Findings of Fact and Conclusions of Law, and pursuant to the authority granted in Chapter 1.62, Florida Statutes, and Section 2, North-Port City Code, it is hereby

ORDERED AND ADJUDGED as follows:

- 5. For fallure to comply with a prior Order of the Code Enforcement Board, Respondent is assessed the sum of \$25.00 per day, beginning March 16, 2015, which shall continue to accrue daily until the property is brought into compliance as set forth in Paragraph 5 and such compliance is confirmed in accordance with Section 2-511 (C), Code of the City of North Port, or until the Maximum Cumulative Fine of \$2,000.00 has been reached.
- 6. A certified copy of this Order may be recorded in the Public Records of Sarasota County, Florida by the City Clerk of the City of North Port and shall constitute a lien upon the real property on which the violation(s) exists and upon the real or personal property owned by the violator(s) consistent with Chapter 162, Florida Statutes, Chapter 2, North Port City Code, for which let execution issue.
- 7. The SPECIAL MAGISTRATE retains jurisdiction in all respects to enforce it prior Order(s) requiring compliance and to issue such Orders having the force of law to command whatever steps are necessary to bring continued violation(s) into compliance: In accordance with \$2-511(d), Code of the City of North Port, if the Maximum Cumulative Fine of \$2,000.00 is reached and Petitioner determines that the violation continues to exist on the property, Petitioner may set a hearing in this cause, with proper notice to Respondent, to determine if any additional fines shall be imposed by the Code Enforcement Board.

As soon as compliance is achieved, Respondent shall notify the Property Standards Division IN WRITING to request a ra-inspection using the "Request for Re-inspection" form that is attached to this Order.

Respondent shall provide the completed form to the Property Standards Division Manager at 4970 City Hall Boulevard, North Port, FL. 34286 or FAX TO (941) 429-7195. Failure to provide the completed written Request for Re-Inspection form to the Property Standards Division Manager will result in the Respondent being assessed additional fines for said violation. Proof of Compliance is required from the Property Standards Inspector before any assessed fine ceases to accrue unless otherwise ordered by the Board.
