A. 17-1444

Third Reading of Ordinance No. 2017-26, Adoption of Fiscal Year 2017-2018 Fire Rescue District Budget.

City Clerk Adkins read Ordinance No. 2017-26 into the record by title only.

Vice-Mayor Yates stated that she does not support the Fire Rescue District Governing Body budget as stated at the second hearing. The assessment revenue is \$ 900.00 but the actual expenditures are approximately 8.4 and an excessive amount of \$860,000.00 is being transferred for future purchases. Over \$200,000.00 is being added to the Fund Balance which is already above the 25% emergency reserve policy and is, with the \$200,000.00, at approximately 47%.

A motion was made by Commissioner Luke, seconded by Commissioner McDowell to approve Ordinance No. 2017-26. The motion carried by the following vote with Vice-Mayor Yates dissenting for reasons previously stated.
