# SECOND AMENDMENT TO AGREEMENT BETWEEN THE SOUTHWEST FLORIDA WATER MANAGEMENT DISTRICT AND CITY OF NORTH PORT FOR CITY OF NORTH PORT BMP ALTERNATIVES ANALYSIS (N682)

This SECOND AMENDMENT entered into and effective the 30th day of April, 2018 by and between the SOUTHWEST FLORIDA WATER MANAGEMENT DISTRICT, a public corporation of the State of Florida whose address is 2379 Broad Street, Brooksville, Florida 34604-6899, hereinafter referred to as the "DISTRICT," and the CITY OF NORTH PORT, a municipal corporation of the State of Florida, whose address is 4970 City Hall Boulevard, North Port, Florida 34286, hereinafter referred to as the "COOPERATOR."

#### WITNESSETH:

WHEREAS, the DISTRICT and the COOPERATOR entered into an agreement effective October 1, 2015, as amended July 25, 2017, (Agreement No. 16CF0000171), hereinafter referred to as the "Existing Agreement," for developing an Alternatives Analysis study to generate feasible solutions to reduce flooding in the area near the Myakkahatchee Creek I-75 and the Jockey Club area, hereinafter referred to as the PROJECT," and

WHEREAS, the parties hereto wish to amend the Existing Agreement to extend the contract period and modify the Project Schedule.

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the parties hereby mutually agree to amend the Existing Agreement as follows:

- 1. The Contract Period Paragraph is hereby amended to extend the expiration date of April 30, 2018 to April 30, 2019.
- 2. The Project Schedule section set forth in Exhibit "A" is hereby replaced in its entirety with the following:
