Axon is a sole source. We currently use Axon and are familiar with axon tasers. The Axon signal technology (which sends a broadcast of status that compatible devices recognize when certain status changes are detected) is only compatible with TASER and Axon products. This means that the Taser Smart Weapons (including Taser 7) can wirelessly report its status, such as being armed or a trigger pull, so Axon cameras can sense specific events and begin recording during critical situations.
