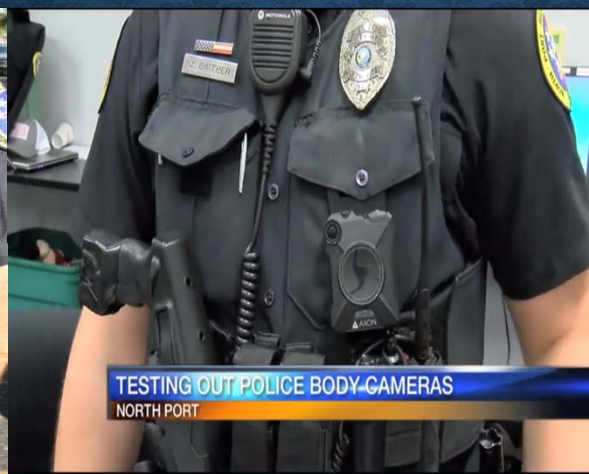




BODY WORN CAMERA PROPOSAL



BODY WORN CAMERA PRESENTATION

- June 7, 2018, staff presented to Commission research and recommendations on Body Worn Cameras (BWC).
 - Presented the history of the BWC.
 - Provided Strengths, Weaknesses, Opportunities and Threats (SWOT) on BWC.
 - Proposed an estimated costs for equipment, personnel & storage both local and cloud based.

BODY WORN CAMERA PROCESS

- Staff created a BWC implementation team.
 - First meeting was held on July 16, 2018.
 - Team selected to pursue one vendor (Axon) who is also a sole source for Taser.
 - Created a NPPD policy for BWC
 - City Attorney review of BWC Policy
 - Commission approved agreement with Axon for field trial of the BWC on November 5, 2018.
 - On November 20, 2018 Axon provided training to our officers and support staff that were assigned to the testing and evaluation on the BWC.





North Port Police Department

The North Port Police Department is currently working towards utilizing officer worn body cameras. A 30 day trial period will begin this week. During the trial 10 officers will be wearing the cameras. Two to three per shift. After the trial period is complete, there will be an evaluation and report generated. That report will be presented to the North Port City Commission at a future date. At that time, the future of body cameras for all of our patrol officers and the financial impact will be discussed and potentially determined.

It's estimated the equipment, storage, and personnel needed to maintain and store records will be in the neighborhood of \$225,000 annually.



BODY WORN TEST AND EVALUATION

- On November 28, 2018 at 6:00 am, BWC's were deployed.
 - 10 BWC's were deployed
 - 2 officers per shift (4 shifts) and both our K9 handlers.

 - Unlimited Evidence through Evidence.com (Storage)
 - Evidence.com mobile app. (Photo and interview features)
 - Axon Records
 - Axon Redaction Assistant
 - Axon Signal Sidearm



TASER 7

- Taser 7 issued to all sworn members
- Unlimited duty cartridges
- 3 training cartridges per officer, per year.
- Taser 7 signal activation for BWC's.
- Evidence.com (data storage)
- Docking Stations.
- Five year warranty
- 4 spare Taser 7s



YEARLY AVERAGE COST

- The average yearly cost to replace tasers and to purchase duty cartridges, training cartridges and batteries is approximately:

\$32,340.00

or \$161,700 over 5 years
