Real estate, land development, or finance; 3. History, culture, folklore, or architectural history or culture, 4. Conservation or curation; 5. Architecture or historic or cultural architecture; 6. Historic or cultural preservation; 7. Land use planning or historic or cultural preservation planning; 8. Historic or cultural landscape architecture; 9. General or building contractor and 10, Professional engineering. No more than 2 members shall be from the same discipline.
