FIRST AMENDED REQUESTED OPERATIONAL and VOLUNTARY COOPERATION AGREEMENT

WITNESSETH:

WHEREAS, the Sheriff's Department of Sarasota County, the Longboat Key Police Department, the North Port Police Department, the Sarasota Police Department and the Venice Police Department, pursuant to the authority granted to them under Part I of Chapter 23, Florida Statutes, known as the Florida Mutual Aid Act, entered into a Requested Operational Assistance Agreement and Voluntary Cooperation Agreement on January 5, 1993; and

WHEREAS, such parties on September 30, 1996, renewed and extended the Requested. Operational Assistance Agreement and Voluntary Cooperation Agreement until September 30, 1999; and

WHEREAS, the Sheriff's Department of Sarasota County, Florida, and the Sarasota Police Department have separately entered into a Requested Operational Assistance Agreement and Voluntary Cooperation Agreement with the Sarasota-Manatee Airport Authority, said Agreements expiring September 30, 1998; and

WHEREAS, the Sheriff's Department of Sarasota County, Florida, the Longboat Key Police Department, the North Port Police Department, the Sarasota Police Department and the Venice Police Department desire to enter into a combined Requested Operational Assistance Agreement and Voluntary Cooperation Agreement with the Sarasota-Manatee Airport Authority and the University of South Florida, acting for and on behalf of the Board of Regents, a public corporation of the State of Florida; and

WHEREAS, the Sarasota-Manatee Airport Authority and the University of South Florida, acting for and on behalf of the Board of Regents, a public corporation of the State of Florida, have the authority under Part I of Chapter 23, Florida Statutes, Florida Mutual Aid Act, the provisions of Chapter 163, Florida Statutes, and other provisions of the laws of the State of Florida, to enter into a Requested Operational Assistance Agreement and Voluntary Cooperation Agreement and wish to enter into such Agreement.

NOW, THEREFORE, in consideration of the foregoing and the covenants hereinafter contained, it is agreed between the parties as follows:

EXHIBIT #1

Section 1.

The Requested Operational and Voluntary Cooperation Agreement entered into between the Sheriff's Department of Sarasota County, Florida, the Longboat Key Police Department, the North Port Police Department, the Sarasota Police Department and the Venice Police Department, effective from January 5, 1993 through and including September 30, 1996, and the renewal of same effective September 30, 1996 through and including September 30, 1999, is hereby incorporated by reference as if more fully set forth herein. Said Requested Operational and Voluntary Cooperation Agreement and renewal are attached herein as Exhibit "A" and "B".

Section 2.

The Sheriff's Department of Sarasota County, Florida, the Longboat Key Police Department, the North Port Police Department, the Sarasota Police Department and the Venice Police Department, hereby agree to the addition of the Sarasota-Manatee Airport Authority and the University of South Florida, acting for and on behalf of the Board of Regents, a public corporation of the State of Florida, into the Requested Operational and Voluntary Cooperation Agreement.

Section 3.

The Sarasota-Manatee Airport Authority and the University of South Florida, acting for and on behalf of the Board of Regents, a public corporation of the State of Florida, do hereby agree to enter into the Requested Operational and Voluntary Cooperation Agreement with the Sheriff's Department of Sarasota County, Florida, the Longboat Key Police Department, the North Port Police Department, the Sarasota Police Department and the Venice Police Department and to be subject to the terms, conditions and immunities as more particularly set forth therein.

Section 4.

This First Amendment to the Requested Operational and Voluntary Cooperation Agreement, as renewed, shall expire on September 30, 1999.

Section 5.

The Sarasota Police Department and the Sarasota-Manatee Airport Authority agree that upon this Agreement becoming effective, the Requested Operational and Voluntary Cooperation Agreement previously entered into between them, expiring on September 30, 1998, shall be revoked.

Section 6.

The Sheriff's Department of Sarasota County and the Sarasota-Manatee Airport Authority agree that upon this Agreement becoming effective, the Requested Operational and Voluntary Cooperation Agreement previously entered into between them, expiring on December 1, 1998, shall be revoked.
