This is in response to your request for information concerning your organization's exemption from Federal income tax.

Because your organization is an Instrumentality of a governmental unit. Its income is not taxable as explained above. Contributions to instrumentalities are deductible under Section 170(c)(1) of the Code.

Hello Jennifer,

I think anyone can fill this out - it doesn't appear to be title-specific. Hopefully I can provide you with the information that you need:

- The City is <u>not</u> a 501(c)(3). Per the attached correspondence from the IRS, a municipality is federally tax exempt under the provisions of Internal Revenue Code Section 115(1). On a side note, North Port Social Services has often provided this letter to donators of their charitable programs as proof of tax exemption.
- Similar to the above answer, the form is specific to 501(c)(3) organizations and not municipalities the City
 doesn't have that same type of management structure. I would list the five elected commissioners and the City
 Manager along with their titles.
- The attached IRS letter should be sufficient for proof of exemption, just not under 501(c)(3). Since we remain in existence as a municipality and have never been notified of any such tax-exempt revocation, you can safely make the statement that IRC Section 115(1) status has not been revoked.

If any of this information is not enough to proceed, don't forget that this is the Foundation's form. If needed, they should be able to give you guidance on how to convert their 501(c)(3) questions/requests to a tax-exempt municipality format. My guess is that the majority of their donated funds go to 501(c)(3) organizations and they haven't adjusted their forms for tax-exempt governmental entities.
