Reference: Spring Haven Drive Reclaimed Water Main Extension – RFB No. 2018-02 Letter of Recommendation

Eight bid submittals were received in response for this Request for Bid (RFB). Of the eight bidders, the apparent low bidder was E.T. MacKenzie of Florida, Inc., with a total bid of \$422,760.00.

The Florida Department of State Division of Corporations database was searched and it was confirmed that E.T. MacKenzie of Florida is an active registered business entity.

Bidders were required to be licensed as a Certified General Contractor or a Certified Underground Utilities Contractor. E.T. MacKenzie of Florida submitted a copy of a Certified Underground Utilities Contractor license. The Florida Department of Business and Professional Regulation website was used to verify that this license is active and that there are no complains on file.

To demonstrate their qualifications, bidders were required to submit a minimum of four references for projects completed in the past five years of similar size and scope. Two of the four references were to be directly applicable to the horizontal directional drill (HDD)work. In addition, the Contractor or their HDD subcontractor were required to have completed three or more HDDs for the construction of water mains utilizing 12-inch or larger HDPE for a length of 800 linear feet or greater.

E.T. MacKenzie of Florida submitted four references. Each of the references was contacted and all responded with positive feedback. No feedback was received that would indicate that E.T. MacKenzie of Florida would perform less than satisfactory work.

Based on the available information and with consideration given to the requirements of the RFB, Stantec recommends that a Contract be awarded to E.T. MacKenzie of Florida to perform the work specified in this RFB.
