RESOLUTION NO. 2016-R-07

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE NORTH PORT SOLID WASTE DISTRICT, PROVIDING FOR ADOPTION, CERTIFICATION AND CONFIRMATION OF THE NORTH PORT SOLID WASTE DISTRICT NON-AD VALOREM ASSESSMENT RATES AND CERTIFICATION OF THE NON-AD VALOREM ASSESSMENT ROLLS FOR FISCAL YEAR 2016-2017, PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Section 66-91 of the North Port City Code, the governing body shall have the duty, right, power and authority to levy, by resolution, and collect special assessments for benefits against all real property within its territorial bounds in order to provide funds for the purpose of the Solid Waste District; and

WHEREAS, pursuant to Section 66-92 of the North Port City Code and in accordance with Florida Statute §197.3632, the governing body shall, by resolution, state its intention to use the uniform method for the levy, collection and enforcement of non-ad valorem assessments. The annual assessments shall be placed on the annual ad valorem property tax bill of the assessed property and shall be collected by the Tax Collector of Sarasota County. The governing body shall certify the non-ad valorem special assessment roll on compatible electronic medium to the tax collector in and for the County of Sarasota pursuant to F.S. § 197.3632(5) on or before September 15th of each year; and

WHEREAS, the special assessments provide funding for the purpose of providing solid waste management service to the residents of the City of North Port, including but not limited to the collection, transportation, storage and disposal of solid waste.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE NORTH PORT SOLID WASTE DISTRICT, TO WIT:

SECTION 1

ASSESSMENT RATES AND CERTIFICATION OF ASSESSMENT ROLLS

- 1.01 - Pursuant to Section 66-91 of the North Port City Code, the City Commission hereby adopts, certifies and confirms the Solid Waste District non-ad valorem assessment rates for fiscal year 2016-2017 to be \$249.00 for each residential unit.

- 1.02 - Pursuant to Section 66-92 of the North Port City Code and in accordance with F.S. § 197.3632, the City Commission hereby adopts and certifies the North Port Solid Waste District non-ad valorem special assessment rolls for the 2016-2017 fiscal year, and authorizes certification of said rolls.

SECTION 2 CONFLICTS

- 2.01 - If there is any conflict between the provisions of this Resolution and any other resolution or portions thereof, the provisions of this Resolution shall prevail to the extent of such conflict.

SECTION 3 SEVERABILITY

- 3.01 - If any section, subsection, sentence, clause, phrase or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions.

SECTION 4 EFFECTIVE DATE

- 4.01 - This Resolution shall take effect immediately upon adoption.
