# **CALL TO ORDER**

The North Port Road and Drainage District Regular Meeting was called to order at 4:01 p.m. in City Commission Chambers by Mayor Hanks.

# 4. GENERAL BUSINESS:

A. <u>19-0307</u> US41 Signalized Intersections Traffic Signal Poles and Mast Arms - Painting City Center Green

Mr. Lear introduced the item.

Ms. Bellia gave an overview regarding Florida Department of Transportation (FDOT) requirement for an interlocal agreement to paint signal poles and mast arms green at five of the U.S. 41 signalized intersections, and is seeking Commission direction regarding budgeting for fiscal year 2020 and forward.

Discussion ensued regarding the total count of 19 poles at Sumter Boulevard, Sumter Crossing, Salford Boulevard, Corradino Boulevard and Islandwalk Circle, and that interpretation of the pattern book requirement for painting City Center green excludes public infrastructure such as traffic signals and street lights.

Ms. Bellia stated that street lights installed by the City or a developer within the state right-of-way are the property and responsibility of the City, and an interlocal agreement with FDOT is required for painting the light poles.

Ms. Bellia spoke to the agreement with FDOT providing funding of \$4,876 per intersection for maintenance of signals not include painting.

Mr. Lear addressed the project time-line, costs being budgeted for next year, the 90-day procurement process, two to three months for painting, and project estimated completion being one-year from now.

Ms. Galehouse explained the West Villages has their own pattern book requiring their streetlights to be painted black, and excluding the two intersections at West Villages the cost would be \$75,000.

# PUBLIC COMMENT

Justin Willis: spoke to the coloring of poles, aesthetics and questioned any warranties are in effect

Steve Nappi: cost versus aesthetics of painting poles, painting older versus newer galvanized poles

A motion was made by Commissioner Carusone, seconded by Commissioner Emrich, to direct staff to allocate \$75,000 for a budget amendment for this year to paint only the three street light intersections within the Activity Center along U.S. 41, City Center green, and to procure as soon as that goes through, and then repaint as needed.

Discussion ensued regarding warranty being included during procurement process.

Vice-Mayor McDowell expressed concern that West Villages is within North Port and community standards should be applied all along U.S. 41, that funds could be spent on amenities and street lights where needed, aesthetics important on main corridors, not U.S. 41.

Commissioner Luke expressed concern for infrastructure needed in the City such as lighting and sidewalks, and to uphold the current interpretation regarding aesthetics.

The motion carried by the following vote, with Vice-Mayor McDowell and Commissioner Luke dissenting for reasons stated:

Yes: 3 - Mayor Hanks, Commissioner Emrich and Commissioner Carusone

No: 2 - Vice-Mayor McDowell and Commissioner Luke

A motion was made by Commissioner Carusone, seconded by Commissioner Emrich, to direct staff to require any development, from this point forward, within the U.S. 41 corridor, in this specific Activity Center, to be the same City Center green, for consistency and clarity.

Ms. Bellia suggested this requirement also be included in the pattern book rather than be left to interpretation.

Ms. Slayton explained Commission can direct staff to bring this portion back, that approving plans for pattern books, special developments and changes to the Code require Planning and Zoning Advisory Board (PZAB) review and two public hearings.

Following discussion Commissioner Emrich withdrew his second and Commissioner Carusone restated the motion.

A motion was made by Commissioner Carusone, seconded by Commissioner Emrich, to have staff bring back whatever means necessary to require the street lighting within the U.S. 41 corridor and Activity Center to be City Center green, including traffic signals, intersection signals, any other signals, as well as the signs.

Ms. Bellia clarified that this will include green pedestrian crossing poles and blue signs.
