## QTY DESCRIPTION

1 24' x 20' x 8' ID 4 users plumbed Restroom/Concession Building. Precast 4" interior and exterior walls with post-tensioned 5" roof and 6" post-tentioned floor. Exterior split faced block finish with hand trowel finished interior walls. Site Assembled, welded connections and Sika Flex caulked. Mechanical chase door located in the concession area not outside between the restrooms.

- . 2-Vents (Sunvent 164) one in each restroom
- . 1-3' x 6' OH coiling door at concession counter locakable with Owner provided pad lock.
- . Interior and exterior walls primed and painted with Sherwin William Loxon primer and Duracraft 2 coats paint.

Exterior Color TBD and Interior walls are while and floors are gray.(Siloxaine Floor Coatings)
