#### ORDINANCE NO. 97-5

(Amendment to the Zoning Regulations of the Unified Land Development Code Ordinance No. 90-28)

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA AMENDING SECTION 3, UNIFIED LAND DEVELOPMENT CODE ORDINANCE NO. 90-28 RELATING TO ZONING REGULATIONS; PROVIDING FOR THE AMENDMENT OF SECTION 3.23, UNIFIED LAND DEVELOPMENT CODE ORDINANCE NO. 90-28 RELATING TO THE ESTABLISHMENT, PROCEDURES AND POWERS GENERALLY; PROVIDING FOR FINDINGS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAÏNED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

- SECTION 1 -AMENDMENT OF SECTION 3.23, UNIFIED LAND DEVELOPMENT CODE ORDINANCE NO. 90-28:
  - 1.01 Section 3.23.1, subparagraphs 1, 4, 6 A, B, C and D, Planning and Zoning Advisory Board, Establishment, Procedures and Powers Generally of the Unified Land Development Code Ordinance No. 90-28 are hereby amended to read as follows:

[NOTE: additions are shown as <u>underlined</u> and deletions are shown as stricken. These editorial notations shall not appear in the codified text.]

#### ORDINANCE NO. 97-5

- Bstablishment and Composition A Planning and Zoning Advisory Board is hereby reestablished, which shall consist of seven (7) regular members to be appointed by the City Commission. each for a term of flour (4) years; provided, however, that not more than a minority of the terms of such Board members shall expire in any one year. Terms of appointment are for four (4) years, however, in case of a vacated position, the new appointment would be for the completion of the vacated term.
- 4. Removal Members of the Planning and Zoning Advisory Board may be removed from office for cause by the affirmative votes of three (3) members of the City Commission. If a member's absences exceed four (4) consecutive or twenty-five percent (25%) scheduled/regular board meetings in a calendar year, excluding special meetings, the Planning and Zoning Advisory Board may recommend to the City Commission that the appointment be terminated. The only exception to this requirement shall be absences due to illness/death in family.

#### 6. Proceedings

- A. Officers and Voting The Planning and Zoning Advisory Board shall select from its membership a Chairman and a Vice-Chairman from among its members and may create and fill and such other offices as it may determine. annually at the first regularly scheduled meeting in January of each year (effective January 1998), to serve a term of one (1) year. The Vice-Chairman shall serve as Chairman in the latter's absence. All members of the Planning and Zoning Advisory Board shall yote on matters before the Board.
- B. Rules of Procedure The Planning and Zoning Advisory Board shall adopt rules of procedure necessary to its governing and the conduct of its affairs, use Roberts Rules of Order as their parliamentary guideline in the conduct of all meetings in keeping with the applicable provisions of Florida Law and these zoning regulations. Such rules of procedures shall be available in written form to persons appearing before the Board and to the public.

#### ORDINANCE NO. 97-5

- C. Meetings Meetings shall may be held on the first and third Thursday of each month, at the call of the Chairman and at such other times as the majority of the Planning and Zoning Advisory Board may determine. provided, that the Board shall hold at least one regularly scheduled meeting each month, except a single month each year, on a day to be determined by the Board. Meetings that are not regularly scheduled shall not be held without proper notice.
- D. Notice of Meetings An agenda shall be posted by the City Clerk in the designated areas of City Hall at least 24 48 hours prior to the a Planning and Zoning Advisory Board meeting.

#### **SECTION 2 - SEVERABILITY:**

2.01 - If any section, subsection, sentence, clause, phrase or portion of this Ordinance for any reason is held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

#### **SECTION 3 - CONFLICTS:**

3.01 - In the event of any conflict between the provisions of this Ordinance and any other Ordinance or portions thereof, the provisions of this Ordinance shall prevail to the extent of such conflict.

#### **SECTION 4 - EFFECTIVE DATE:**

4.01 -This Ordinance shall take effect immediately upon final adoption pursuant to the provisions of Section 9.09, North Port Charter.
