## **General Comments**

Pool is not properly skimming or being filtered as needed to ensure proper water quality. Pool must be cleaned, water level must be adjusted, cracks in shallow end must be patched, and cracked tiles must be repaired or replaced by 6/28/19. Provide a timeframe for complete resurfacing of pool.

Pool will be immediately closed by DOH as not being in compliance whenever any of the following conditions occur: \*Disinfectant level is below the minimum (or above maximum) prescribed by 64E-9

\*pH of pool water is below 7.2 or above 7.8

The clarity of the pool water is such that the main drain grate is not readily visible from the pool deck\*

\*Recirculation system or disinfection feeding equipment is missing or not functioning.

Other conditions exist such as drowning hazard, sharp edges/broken tiles, fecal accident(s) or visible biological growth.

Low flowrate for pool recirculation is a violation of 64E-9 and FBC 454. Flowrate must be corrected within 90 days (9/22/19). Official Notice of the violation will be sent to the jurisdictional building official.

FBC 454.1.6.5.2 Volume.

The recirculation system shall be designed to provide a minimum of four turnovers of the pool volume per day. Pools that are less than 1,000 square feet (93 m2) at health clubs shall be required to provide eight turnovers per day.

## **Violations Comments**

Violation #1. Water Clarity/Algae Control

Dirt and debris need to be removed from the pool, please vacuum pool.

CODE REFERENCE: Pool Appearance/Algae/Clarity. 64E-9.004(1)(c) & (3); 64E-9.017(1)(c). The pool shall be free from floating debris, sediment, dirt, algae. The main drain shall be visible.

Violation #3. Tile/Pool Finish

Cracks in pool surface at the shallow end need to be patched. Large crack in deep end wall needs to be addressed (pool plaster is on pool floor). Broken waterline tiles need to be repaired or replaced.

CODE REFERENCE: Tile/Pool Finish. 64E-9.004(3); 64E-9.017(1)(h). Pool finish and tile shall be maintained in a safe and sanitary condition.

Violation #27. Water Level/Control

Water level is high; maintain water level to provide for continuous skimming.

CODE REFERENCE: Water Level/Control. 64E-9.004(6); FBC 454.1.6.5.11. The pool water level shall be maintained for continuous skimming flow during periods of non-use. A manual and automatic fill device shall be provided and shall discharge into the collector tank.

Violation #35. Pressure/Vacuum Gauge

Provide a vacuum gauge before the recirculation pump.

CODE REFERENCE: Pressure/Vacuum Gauges. 64E-9.008(10)(d). All vacuum filter systems shall have a functional vacuum gauge before the pump. All pressure filter systems shall have a functional pressure gauge mounted before and after the filter.

#### Violation #41. Other Equipment

Flowmeter reading appears to be below the range of the flowmeter (<170gpm). Maintain flowrate of 443gpm (within 20 percent). Repair equipment or plumbing as needed to attain the required flowrate. FBC type violation - must be corrected within 90 days. CODE REFERENCE: Other Equipment. 64E-9.008(10). Auxiliary equipment must not interfere with the attainment of the design flow, i.e. ionizers, UV,

ozone generators, heaters, etc.
