Petitions: Index Map Amendment



This amendment proposed the following changes to the Index Map:

- Addition of three approved fire/police station locations
- 2. Updates to village boundaries and acreages for Villages F, G, J, K, and L
- Updates to roadway alignments
- Adjustment/relocation of Village Centers
- 5. Revision to park acreages (in Village D and Village H)
- 6. Addition of utility site location in Village F
- 7. Identification of potential school sites
- 8. Identification of hotel site in Village G

Petitions: Village F Pattern Plan Amendment



This amendment proposed the following major changes to the Pattern Plan:

- Adjustment of roadway alignments (Manasota Beach Rd)
- 2. Addition of ±8 acres to the southwest corner of the village
- 3. Adjustment of neighborhood layout to add an additional residential neighborhood

- Staff reviewed the Village F Pattern Plan Amendment for consistency with:
 - Comprehensive Plan
 - Unified Land Development Code

Petitions: Village G Pattern Plan Amendment



This amendment proposed the following major changes to the Pattern Plan:

- Adjustment of roadway alignments (Manasota Beach Rd)
- 2. Addition of ±41 acres to the southwest corner of the village
- Adjustment of neighborhood layout

- Staff reviewed the Village G Pattern Plan Amendment for consistency with:
 - Comprehensive Plan
 - Unified Land Development Code
