ORDINANCE - First Reading

A. ORD. NO. 2019-22

An Ordinance of the City of North Port, Florida, Amending the Non-District Budget Fiscal Year 2018-19 by Providing for Changes Identified in Exhibits A and B; Providing for Conflicts; Providing for Severability; and Providing an Effective Date

There being no objection, Ms. Taylor read Ordinance No. 2019-22 into the record by title only.

Mr. Lear provided an overview of the item, and clarified the projects to which the Impact Fees may be applied vs. the Solid Waste District Fund Balance Policy.

Ms. Bellia and Mr. Lama provided an update regarding the City's recycling program progress, the expected facility opening date, and total expenditures to date for the project.

Ms. Ferrell explained the discrepancy between the \$180,000 budget amendment to the Capital Improvement Program (CIP) last October and the amount of \$171,000 in the CIP now, and why the telescopic loader is not listed as a CIP project but is listed with other vehicles.

Mr. Lear clarified that vehicles funded from surtax monies are listed as a CIP project.

After a concern was expressed that a Charlotte County recycling vehicle was seen scattering cardboard on Tropicaire Boulevard, staff stated they will investigate further.
