Background Information

This request represents one Tegile Storage Area Network (SAN), associated equipment and professional implementation services that will be placed in our primary datacenter, located in City Hall. Information Technology has created a disaster recovery center in cooperation with Sarasota County, utilizing their datacenter. The existing Tegile SAN will be migrated to the disaster recovery center. Disaster recovery equipment provides backup and recovery functionality for important City data and systems. This is critical in ensuring business continuity in the event of a disaster.
