ORDINANCE NO. 2025-02

1 **AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE CODE OF THE**
 2 **CITY OF NORTH PORT, FLORIDA, SECTION 74-151; TO DESIGNATE ADDITIONAL CITY**
 3 **ROADWAYS FOR THE OPERATION OF A GOLF CART; PROVIDING FOR FINDINGS;**
 4 **PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR**
 5 **CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.**

 7 **WHEREAS**, Florida Statutes Section 316.212 authorizes the use of a golf cart upon any City street that the
 8 City has designated for golf cart use, provided that appropriate signage is posted; and

9
 10 **WHEREAS**, the City Commission of the City of North Port has designated certain City streets for golf cart
 11 use; and

12
 13 **WHEREAS**, the City Commission has considered factors including the speed, volume, and character of
 14 motor vehicle traffic on additional City streets not currently designated for the use of golf carts; and

15
 16 **WHEREAS**, the City Commission has determined that additional City streets should be designated for the
 17 operation of golf carts; and

18
 19 **WHEREAS**, the City Commission finds that this amendment serve the public health, safety, and welfare of
 20 the citizens of the City of North Port, Florida.

21
 22 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

 24 **SECTION 1 – FINDINGS**

25
 26 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

27
 28 1.02 In accordance with Florida Statutes Section 166.041(4)(a), the City timely posted a business
 29 impact estimate on the City’s website on or before the date the newspaper published notice of
 30 this ordinance’s final reading.

31
 32 **SECTION 2 – ADOPTION**

33
 34 2.01 Chapter 74 of the Code of the City of North Port, Florida is hereby amended as follows:

35
 36 **“CHAPTER 74 – Traffic and Vehicles**

37 . . .

38 **ARTICLE VI. – GOLF CARTS AND LOW SPEED VEHICLES**

39 . . .

40 **Sec. 74-151. – Golf carts.**

41

42 (a) *Golf cart operation.* The operation of a golf cart is only permitted on private property,
43 designated city roadways, on a golf course, and golf course accessory property.

44

45 (b) *Designated city roadways.* The operation of a golf cart is only authorized on designated city
46 roadways where appropriate signage is posted in compliance with F.S. §316.212(1). The city
47 designates the following roadways:

49 (1) All city roads in Holiday Park Recreational District;

50

51 (2) All city roads in Lakeside Plantation Community Development District; ~~and~~

52

53 (3) Plantation Boulevard; and

54

55 (4) All city roads in Renaissance at West Villages.

57 . . .”

58

59 **SECTION 3 – CONFLICTS**

60

61 3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in
62 whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

63

64 **SECTION 4 – SEVERABILITY**

65

66 4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase,
67 or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be
68 deemed a separate, distinct, and independent provision and will not affect the validity of the
69 remaining portions of the ordinance.

70

71 **SECTION 5 – CODIFICATION**

72

73 5.01 In this ordinance, additions are shown as underlined and deletions as ~~striketrough~~. Any
74 additional codification information and notations appear in *italics*. These editorial notations are
75 not intended to appear in the codified text.

77 **SECTION 6 – EFFECTIVE DATE**

78

79 6.01 This ordinance takes effect immediately upon adoption.
