CALL TO ORDER

Mayor Langdon called the meeting to order at 4:00 p.m.

ROLL CALL

Present: 5 - Mayor Barbara Langdon, Vice Mayor Alice White, Commissioner Pete Emrich, Commissioner Debbie McDowell and Commissioner Philip Stokes

City Manager Jerome Fletcher, Deputy City Attorney Michael Golen, City Clerk Heather Faust, Recording Secretary Matthew Powell, Deputy Police Chief Chris Morales, and Public Works Director Chuck Speake

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was led by Deputy Police Chief Chris Morales.

1. APPROVAL OF AGENDA

Mayor Langdon requested a motion.

A motion was made by Commissioner McDowell, seconded by Commissioner Emrich, to approve the Agenda as presented. The motion carried on the following vote:

3. CONSENT AGENDA:

Mayor Langdon announced the item, queried the City Manager regarding items pulled from the Consent Agenda for discussion, and requested a motion.

Mr. Fletcher noted items pulled from the Consent Agenda for discussion.

A motion was made by Commissioner McDowell, seconded by Commissioner Stokes, to approve the Consent Agenda with the exception of Item No. 23-0361 being pulled for discussion. The motion carried on the following vote:

Approve Final Revisions to the Road and Drainage District Rates & Methodology Study Completed by Stantec Consulting Services, Inc.

Mayor Langdon introduced the item.

Commissioner McDowell spoke to not approving the rates and methodology study prior to viewing and discussing the exempt properties, policies, and potential revenues.

Mr. Speake spoke to the item regarding transportation impact fees changing to mobility fees, regulatory versus discretionary exemptions, number of exempt properties, potential revenue, and majority of exempt properties belonging to churches.

Commission questions and discussion took place regarding portion of exempt properties belonging to churches, time constraint to review memorandum, collecting fees for stormwater, fee collection process compared to other municipalities, approval of methodology versus rates, determining exempt properties prior to approval of rates and methodology study, staff review process regarding exempt properties, and Commission direction regarding determining exempt properties timeline.

Mayor Langdon requested a motion.

A motion was made by Vice Mayor White, seconded by Commissioner Emrich, to approve Item No. 23-0361 as presented.

Commission questions and discussion continued regarding discussion of exempt properties timeline, and cost effectiveness for review.

The motion carried on the following vote:

No: 1 - Commissioner McDowell

Commissioner McDowell dissented due to reasons stated.

A motion was made by Commissioner McDowell, to instruct the City Manager, City Attorney, and staff to bring forward an Agenda item including the 71 discretionary exempt properties to remove the exemption as necessary.

Commission discussion took place regarding verbiage and intent of the motion relating to reviewing and modifying property exemption status.

The motion was restated by Commissioner McDowell, to instruct the City Manager

and City Attorney bring forward an Agenda item to remove the Road and Drainage exemption from the exempt properties with a list of each property and its potential revenue for further discussion within the next 60 days. The motion failed due to lack of a second.
