MINUTES APPROVED AT THE 11-27-2018 MEETING

CALL TO ORDER/ROLL CALL

The North Port City Commission Special Meeting was called to order at 11:03 a.m. in City Commission Chambers by Mayor Carusone.

Present: Mayor Carusone; Vice-Mayor Yates; Commissioners, Hanks, Luke and McDowell, City Manager Lear; City Attorney Slayton; Interim City Clerk Peto.

The Pledge of Allegiance was led by the Commission.

1. APPROVAL OF AGENDA – COMMISSION

A motion was made by Commissioner Hanks, seconded by Commissioner McDowell, to approve the Agenda. The motion carried by the following vote.

Yes: 5 - Mayor Carusone, Vice-Mayor Yates, Commissioner Hanks, Commissioner McDowell and Commissioner Luke

2. PUBLIC COMMENT:

There was no public comment.

3. WELCOME OF NEW EMPLOYEES:

A. [18-652](#) New Employee Recognition

Human Resources Director McDade introduced the City's newest employees in the City Manager's Office, Human Resources, Neighborhood Development Services, Parks and Recreation, the Police Department and Public Utilities.

5. PRESENTATIONS

A. [18-654](#) Police Department Presentation.

Police Chief Garrison provided a PowerPoint presentation.

Discussion ensued: (1) training for the Assist program may be available in 2019 for the first responders; (2) once the last two open positions are filled the Police Department will be fully staffed; (3) the Police Department has Crisis Intervention Training that is a 40 hour advanced class specifically for first responders; (4) the parking area will be considered during the expansion of the Police Department and may include a parking garage; (5) the Police substation in the West Villages will be addressed in conjunction with the Fire Department. There was no public comment.

B. [18-666](#) Presentation by Thomas Noyes, City of North Port's Representative to the Sarasota County Bicycle/Pedestrian/Trail Advisory Committee.

City of North Port's Representative to the Sarasota County Bicycle/Pedestrian/Trail Advisory Committee Thomas Noyes provided a PowerPoint presentation.

Discussion ensued: (1) a suggestion was made to have Staff review having a crosswalk between the two entrances of Heron Creek over Price Boulevard; (2) the right of way ownership should be reviewed to determine who is responsible for maintenance; (3) it was suggested that the Committee consider North Port as part of a rotating meeting location; (4) a suggestion was made to install a sidewalk ends sign on Price Boulevard near the Heron Creek entrance. There was no public comment.

6. PUBLIC HEARING**A. [18-694](#) Second Reading, Ordinance No. 2018-22, Commission Compensation**

Interim City Clerk Peto read Ordinance No. 2018-22 into the record by title only.

Discussion ensued: (1) the intent was to have the second reading as an evening meeting for the benefit of the public and it was suggested to table this item until after the reading of Proclamations.

PUBLIC COMMENT

Kent Anderson: Commission compensation.

A motion was made by Vice-Mayor Yates, seconded by Commissioner Hanks, to continue Ordinance No. 2018-22 to take place at the conclusion of Item 4.L. The motion carried by the following vote:

7. GENERAL BUSINESS:**A. [18-696](#) River Road and Impact Fee Update**

City Manager Lear gave a presentation of the item.

Discussion ensued: (1) it was explained that Sarasota County is looking at a State Infrastructure Bank (SIB) loan, and that their backup source is unknown; (2) though a specific dollar amount will be pledged, the agreement will provide that half of the West

Villages impact fees collected is to be accepted as the payment obligation; (3) transportation impact fees must be spent as a unique benefit to the development that generated the fee, which may also benefit the general public; (4) everyone, including West Villages, pays the same transportation impact fee; (5) Price Boulevard widening is the only project in the Capital Improvement Program (CIP); (6) \$1,600,000 of the \$3,200,000 impact fees projected for 2019-2020 is from West Villages; (7) a suggestion was made to allocate 75% of West Villages impact fees to the River Road widening project and the remaining 25% be utilized for other transportation projects; (8) it was suggested to review the \$8,000,000 Sarasota County impact fee collected from the City of North Port in 2009-2010 that was spent on West Villages; (9) a suggestion was made to allocate West Villages impact fees to the River Road project as that is the only current project those monies can be spent on, and it will lessen the loan amount and interest payment; (10) prepayment and payoff will be reviewed for any negative impacts.

A motion was made by Commissioner McDowell, seconded by Commissioner Luke, for a \$2,000,000 down payment at the beginning of the project and dedicating 50% of all West Villages District Transportation Impact Fees collected for the life of the loan on an annual basis and providing a cap amount of \$6,000,000, contingent on the SIB loan being approved. The motion carried by the following vote:

Discussion continued: (1) there was discussion regarding the stop lights at Gran Paradiso and Islandwalk; (2) it was suggested that Staff communicate with West Villages Improvement District for feedback on the date of installation of the traffic lights; (3) Staff will review the development order to see if it provides a date for installation, a letter will be sent to the developers requesting an update with a specific date and Marty will be copied on the correspondence. There was no public comment.

B. [18-673](#)

Discussion and possible action regarding William Bowteck, member of the Public Utility Advisory Board.

Interim City Clerk Peto provided an overview of the item.

Discussion ensued: (1) the City Code provides that members of the boards and committees must maintain residency within the City for their term in office; (2) this member claims his residency in North Port while his home is being built here; (3) it was explained that if his residency is in North Port he meets the Code requirements; (4) it was suggested the Code be amended to provide a provision for emergency situations. There was no public comment.

6. PUBLIC HEARING

A. [18-694](#) Second Reading, Ordinance No. 2018-22, Commission Compensation

Discussion ensued: (1) it was explained that the ordinance does not need to provide a specific time frame to forego a pay increase because it provides for salaries to take effect each October 1; (2) it was suggested to use the City Manager's recommended salary of \$32,161 which aligns with the increases received by employees; (3) concern was expressed that the Commission receives benefits greater than what average employees receive and that the entire benefit package should be taken into consideration; (4) there isn't a written job description for the Commission and their involvement in events is discretionary, it was suggested that Commission salary be on the ballot as a referendum; (5) Commissioner Hanks expressed concern that a Commissioner seat is designed to be served by the average citizen, that the Commission is overthinking their positions, and that there is a better way to handle this; (6) it was noted that approving the item as presented means a salary of \$30,776, which is a \$1,600 increase.

A motion was made by Vice-Mayor Yates, seconded by Commissioner McDowell, to approve Ordinance No. 2018-22 as presented. The motion carried by the following vote, with Commissioner Hanks dissenting for reasons stated:

9. PUBLIC COMMENT:

There was no public comment.

10. COMMISSION COMMUNICATIONS:

Commissioner Hanks: nothing to report.

Commissioner McDowell reported attending: (1) National Night Out; (2) Community Action Agency Board (CAAB) meeting in Sarasota; (3) the Peace River Manasota Water Management meeting; (4) will be attending the National League of Cities (NLC) conference in California.

Vice-Mayor Yates: (1) her last day on the Commission will be November 5; (2) attended the City Economic Development Advisory Board (CEDAB) meeting and noted that they need more members to serve on their advisory board; (3) Manasota League of Cities meet the second Thursday each month, with the next meeting on November 8; (4) suggested that someone attends the Public Transportation Task Force (PTTF) meeting and the Metropolitan Planning Organization (MPO) meeting on November 8.

Discussion ensued: (1) the Commission was encouraged to continue serving on the transportation and governmental relations committee with the NLC and promote projects within the City of North Port; (2) it was explained that while Vice-Mayor Yates is in office Commissioner McDowell could speak to her regarding the generalities of how the committee works and how to prepare for meetings, and that they may not discuss issues that could come before the Commission; (3) it was suggested that Staff prepare a list of all board and committee positions that are open for Commission review; (4) Commissioner Hanks stated he may be able to attend the PTTF and MPO meetings on November 8; (5) a suggestion was made to send a letter to Manasota League of Cities to let them know why there will not be a representative present for the November 8 meeting; (6) it was suggested that the City Attorney review if Commissioners can sit as a

non-voting member on City boards.

Commissioner Luke reported attending: (1) the Sarasota County Economic Development Corporation (EDC) and met with Dustin; (2) the Peru Trade Show with the Port of Manatee; (3) Career Fair sponsored by Chamber of Commerce; (4) National Night Out; (5) Gulf Coast Builders Exchange (GCBX) in Sarasota; (6) suggested continuing the social media campaign for an additional six weeks to fill advisory board seats; (7) Toys for Tots will be setting up in North Port at the Coldwell Banker building on U.S.41, residents can contact Social Services for further information; (8) Snowbird Baseball is in discussion with the Braves to utilize the North Port field.

Mayor Carusone: nothing to report.
