| <p>Body Worn Camera Used</p> <p>NARRATIVE</p> <p>On Tuesday, October 21, 2025, at approximately 2024 hours, while on uniform marked patrol in the city of North Port, Sarasota County, Florida, I responded to 6207 W Price Blvd (Morgan Center) in reference to a disturbance.</p> <p>Upon arrival, I made contact with Gregg F. Doucette [REDACTED] who from here on out will be referred to as the victim. The victim advised he was battered by a male later identified as Tedarrium A. Deas Jr (B/M DOB 10/12/1996) during a basketball game.</p> <p>Both the victim and Tedarrium provided me with statements. The victim advised he was at the Morgan Center playing in a men's adult basketball league when he ran into an opposing player which resulted in the opposing player falling to the ground. As the victim ran down the court, he was approached by Tedarrium, who struck him in the face as retaliation.

Tedarrium was ejected from the game and no longer on scene at the time of my arrival. I made landline contact with Tedarrium who currently lives outside the jurisdiction and refused to meet with me for an in-person statement.

In the [REDACTED] I observed the interaction between the victim and the opposing teammate where the victim runs into the opposing teammate causing him to fall to the ground. The other players on the opposing team, including Tedarrium are visibly upset as the victim turns away and begins to run down the sideline.

Tedarrium then turns towards the victim and begins to run towards him, ultimately striking him in the face. There was no interaction between Tedarrium and the victim prior to this incident. The battery was unprovoked and done with malice.

I collected a written statement from the victim, and he was provided with Marsy's law information on scene. The victim sustained injury to the right side of his lip which was photographed and uploaded to evidence.com. The victim advised he did not need medical attention.
