While reviewing [REDACTED] of the incident you observe Weston sitting on a chair in the recreation room when Achilles walks into the room. It appears that both parties were making statements to one another when other unidentified children in the area appeared to attempt to separate them and deescalate the situation. [REDACTED] it is observed both parties in close proximity to one another standing chest to chest continuing to yell at one another. [REDACTED]

When Achilles grandfather, Alvin Singleton arrived on scene, I explained to him what had transpired and that [REDACTED] After explaining this to him he advised that he did not wish to pursue charges and completed a complaint withdraw.

When Weston's mother, Emily Weston, arrived on scene, she was explained what had transpired and that [REDACTED] After explaining this to her she advised that she did not wish to pursue charges and completed a complaint withdraw.

Destiny Garrett, the Rec Supervisor requested that [REDACTED] both Weston and Achilles be trespassed from the property. Trespass warnings were completed as well as the city property trespass appeal form. All parties were explained the trespass as well as the appeal process and advised that they understood.

[REDACTED] was uploaded to evidence.com via the citizen link.

While speaking to both parties no injuries were observed on either party.

This concludes my involvement with this case at this time.
