1. You may pay the amount charged for the violation in person at the North Port Police Department, 4980 City Hall Boulevard, North Port, Florida. Monday through Friday, 9:00 A.M. to 4:00 P.M. except holidays.
2. You may pay the amount charged for the violation by U.S. Mail to the North Port Police Department, 4980 City Hall Boulevard, North Port, Florida 34286. Payment can be made by Cashier's Check or Money Order, payable to the City of North Port, Florida. Cash will be accepted in person.
DO NOT MAIL CASH.
3. You may appear in court by requesting a court date. This may be done by contacting the Clerk of the Court within ten (10) days of the issue of this summons by mail or in person at 4000 South Tamiami Trail, Venice, Florida 34293, Monday through Friday, 8:00 A.M. to 5:00 P.M. except holidays. If you are requesting a court date by mail, you must include this copy of the summons.

If you elect to pay this fine rather than appear in court, check your plea below and sign where indicated. Mail this copy with your payment or bring it to the North Port Police Department. You are entitled to be represented by an attorney, if you so desire.
