

What is an EOC?



Tropical Storm Elsa

Impacted by 10.75 inches of rain in a 3-hour period over the watershed

4 feet of water in the Estates

Only North Port was impacted

• "We need to be better prepared to be selfsufficient. Understanding that we will never be able to obtain all the resources we will ever need to meet all possible situations, we should always strive to be able to address the needs of the community in a manner that best serves them, regardless of the conditions, with what we have."



Hurricane Ian

City received damaging winds and 21.45" of rain and city-wide flooding

Over 2 million tons of debris

Statewide impacts creating competition for resources

Documented need for an EOC:

- "The City Hall conference room that the EOC is located in is very limited in terms of space which provides a significant limitation in terms of personnel that can operate out of a central location."
- "It would be prudent to have an EOC building with showers, kitchen, and proper storm protection."
- "Need to have backup water supply."
- "The GIS group should also have a dedicated workspace to concentrate on real time updates to critical projects."
- "Continue with planning for a new EOC."







2024 Season

Hurricane Debby: 17" of rain caused flooding in Sarasota

Hurricane Helene: Catastrophic storm surge

 Pushed water up the Myakka – Fire Rescue provided mutual aid to Sarasota County

Hurricane Milton: Winds and Surge

- Debris
- Power outages
- Discussed safety of staying in City Hall
- Personnel issues due to lack of space
- Back-to-Back activations

Answering Your Questions

Why can't the EOC be a conference room?	The EOC needs to have a large coordination room, breakout rooms, GIS/IT rooms, a Call Center, a Joint Information Center, sleeping space, backups, and wrap around resources to support 24-hour operations.	
Why do we need an EOC when the County has one?	The County is an outstanding resource, but when there is a County-wide disaster, North Port may not be their number 1 priority if other areas were hit harder than we were. We need to be self-sufficient.	
What happens if we do not build the EOC?	City Hall will continue to be the EOC. We will not be ready for no-notice events, and the building will not support 24/7 operations or major hurricane response.	
Why not use FEMA grants?	We looked into this, but the cost to build to the standards required by the grant would increase the cost of the project more than the grant funding would cover.	
Can we put this building with the new PD Headquarters?	This project is an immediate need and accomplishing this now will meet the need at the cheapest price possible. Putting this building with PD Headquarters would cost money to redesign, and there would be cost escalation as well.
