Discussion and Possible Direction Regarding a City of North Port Debt Management Policy and Debt Finance Committee.

Mayor White announced the item.

Mr. Fletcher introduced the item.

Jeremy Niedfeldt, PFM Advisors, provided a presentation including outline, City Charter, comparable debt limits, policy objectives, policy defined, components, affordability measures, historical trend, scorecard approach, ratings criteria, peer analysis, debt per capita, debt to taxable assessed value, debt service as a percentage of operating revenues, debt finance committee, debt structuring, considerations, issuance and management, potential financing team members, primary bond sales method, compliance requirements, overview of financing process, and use of derivatives.

Commission questions and discussion took place regarding credit rating factors, debt affordability measures, revenue fund cap applied to debt services, interfund borrowing, management policy usage, target debt per capita target, surtax, revenue usage, metric usage, fiduciary responsibility, city metrics comparison, default examples, company history, current debt, credit debt verses debt allowance, long term financing, taxable value, individual district's debt, payment calculation, guidelines, annual reporting, citizen input, potential lenders, amending debt management policy, debt service payments, deal approval process, direction requested, and timeline.

Recess was taken from 12:32 p.m. to 1:15 p.m.

Commission questions and discussion continued regarding backloading utilization, frontloading versus backloading, fixed interest versus variable interest debt, variable interest debt utilization, revenue debt use of general fund, loan comparison, advisory board intent and membership criteria, debt management policy guidelines and process, removing designated Commissioner for advisory board, citizen involvement, debt payment process and consequences, default process, and risk assessment.
