NOTICE OF CONTINUANCE





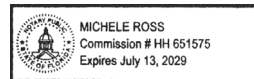
