



First Amendment to the Master Services and Purchasing Agreement

This First Amendment ("First **Amendment**") is between Axon Enterprise, Inc. (f/k/a Taser International, Inc.), a Delaware corporation ("**Axon**"), and the City of North Port, Florida ("**Agency**"). Axon and Agency are each a "**Party**" and collectively "**Parties**".

Axon and Agency are Parties to the Master Services and Purchasing Agreement by and between Axon Enterprise, Inc. and the City of North Port, Florida, Florida, dated November 28, 2023 (the "Original **Agreement**").

The Parties wish to incorporate further changes into the Agreement in order to expand the scope of offered products.

The Parties therefore agree as follows:

1. Effect of Amendment/Effective Date
 - a. The parties ratify the terms and conditions of the Original Agreement not inconsistent with this First Amendment, all of which are incorporated by reference as if set forth fully herein. This First Amendment modifies the sections of the Original Agreement as identified herein. Where a section of the Original Agreement is not identified, the terms as they appear in the Original Agreement remain and apply.
 - b. All references to this "Agreement" in the Original Agreement and this First Amendment mean and include both the Original Agreement and this First Amendment.
 - c. This First Amendment is effective as of the date the last party approves or executes it, as applicable (the "Effective Date"), and shall continue as otherwise provided in the Original Agreement.
2. The attached Fleet Statement of Work for the purchase of the Axon Fleet in-car video solution ("Fleet") and its supporting information, services, and training (AXON Technical Project Manager/The AXON installer") is hereby added to Original Agreement and incorporated as if fully set forth therein.
3. The following language is added in to the Axon Cloud Services Terms of Use Appendix attached and incorporated to the Original Agreement:
 - a. New section (1)(e) – Definitions. Section 1(e) is added to the Original Agreement and will read as follows: "**Provided Data**" means de-identified, de-personalized, data derived from Agency's TASER energy weapon deployment reports, related TASER energy weapon logs, body-worn camera footage, and incident reports.
 - b. New section (1)(f) – Definitions. Section 1(f) is added to the Original Agreement and will read as follows: "**Transformed Data**" means the Provided Data used for the purpose of quantitative evaluation of the performance and effectiveness of TASER energy weapons in the field across a variety of circumstances.
 - c. New section (1)(g) – Definitions. Section 1(g) is added to the Original Agreement and will read as follows: **TASER Data Science Program**.
 - i. Axon will provide a quantitative evaluation on the performance and effectiveness of TASER energy weapons in the field across a variety of circumstances.
 - ii. If Agency purchases the TASER Data Science Program, Agency grants Axon, its affiliates, and assignees an irrevocable, perpetual, fully paid, royalty-free, and worldwide right and license to use Provided Data solely for the purposes of this

- Agreement and to create Transformed Data. Agency shall own all rights and title to Provided Data. Axon shall own all rights and title to Transformed Data and any derivatives of Transformed Data.
- iii. Axon grants to Agency an irrevocable, perpetual, fully paid, royalty-free, license to use to TASER Data Science report provided to Agency for its own internal purposes. The Data Science report is provided "as is" and without any warranty of any kind.
 - iv. In the event Agency seeks Axon's deletion of Provided Data, it may submit a request to privacy@axon.com. Where reasonably capable of doing so, Axon will implement the request but at a minimum will not continue to collect Provided Data from Agency.
4. Quote Q-610598-45771AP is added in to the Quote Appendix attached and incorporated to the Original Agreement as Number 12 in the Quote Appendix list.
5. New section 18.13 – Amendment. Section 18.13 is added to the Original Agreement and reads as follows: No amendment, change, or addendum to this Agreement is enforceable unless agreed to in writing by both parties and incorporated into this Agreement. Any amendments changing the City's financial obligations under this Agreement shall require approval by the City Commission. The City Commission hereby authorizes the City Manager or City Manager's authorized designee to approve and execute all Agreement amendments on behalf of City that do not change the City's financial obligations under this Agreement.
6. All other terms and conditions of the Agreement shall remain unchanged and in full force and effect.

Each representative identified below declares that they are an authorized representative of the respective Party with authority to execute this First Amendment as of the date of signature.

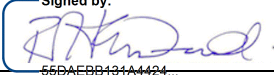
