## NOTICE OF AGGRIEVED AND ADVERSELY AFFECTED PERSON

- 1. The City of North Port has issued an Affidavit of Violation and Notice of Mandatory Hearing for May 22, 2025, regarding the above-referenced property.
- 2. Pursuant to the Contract for Purchase and Sale of Real Property dated September 8, 2023, between Minh B. Nguyen (Owner/Seller) and Lincoln Capital Acquisition LLC (Buyer), Lincoln Capital Acquisition LLC has an equitable and legal interest in the subject property as a contract purchaser under Florida law. Lincoln Capital Acquisition LLC desires to

appear at all proceedings to present testimony and evidence, cross-examine witnesses, and participate as described in the City's procedures for quasi-judicial proceedings.
