NARRATIVE

On July 30, 2024, at approximately 1244 hours, I responded to 12200 San Servando Ave. (Warm Mineral Springs Park) in reference to a trespass. The complainant, Ezequiel De Leon called wanting a subject, who had already left the area, trespassed from the park.

Upon my I made contact with Ezequiel who said he wished to have a female named Anna Bernadsky, trespassed from the property. Ezequiel said that while they were escorting patrons out of the park (due to lightning), Anna, stopped and allegedly peed. Ezequiel said he witnessed Anna stop, squat, and urinate. I asked Ezequiel if Anna had removed any of her clothing during this incident and he said she had not.

After briefly speaking with Ezequiel, I did some research and located an address for Anna at 6961 Willow Creek Cir. APT #203. Prior to responding to Anna's residence, I made contact with Devon Poulos, who is authorized to sign the trespass paperwork. After briefly speaking with Devon, I responded to Anna's residence.

I made contact with Anna who spoke minimal English. I used a translator through Propio for Russian to speak with Anna. I asked Anna if anything occurred at the Warm Mineral Springs Park and explained to her what staff said she did. Anna denied the allegations and said she was wet from the water and that she did not urinate while getting "kicked" out of the park at approximately 1200-1230 hours. Anna said that she is elderly and walks slowly due to medical issues. Anna also said she was waiting for her caretaker who had been swimming. Based on what Anna told me occurred I told her I would call Ezequiel again to verify what occurred.

After speaking with Anna, I called Ezequiel back to clarify a few things and make sure this was not a misunderstanding. I asked Ezequiel if he witnessed this incident firsthand, which he said he did. I told Ezequiel that Anna alleged she was just wet and that she never urinated. Ezequiel said he did not see any wet marks and then saw a stream after Anna began to squat. While I was on the phone with Ezequiel, he mentioned the incident was [REDACTED]. At this time, I have yet to receive any sort of [REDACTED] of the incident.

Per the request of staff, Anna was issued a public property trespass from Warm Mineral Springs Park. Due to the severe language barrier, I used a translator to explain to Anna how to appeal the trespass. Anna was extremely frustrated over the situation and became very worked up over the issue. Anna ultimately refused to sign the trespass paperwork. She was provided with a copy for her records. The original trespass was signed by Devon Poulos and turned in.

This incident occurred in the City of North Port in Sarasota County, Florida.
