ORDINANCE NO. 2023-33

1 **AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, PROHIBITING SMOKING AT**
2 **PUBLIC PARKS; AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA TO**
3 **CREATE A NEW SECTION 46-64; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS;**
4 **PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN**
5 **EFFECTIVE DATE.**

6
7 **WHEREAS**, Florida Statutes Chapter 386 (the Florida Clean Air Act) preempts the regulation of smoking in
8 the State of Florida; and

9
10 **WHEREAS**, Florida Statutes Section 386.209 provides that a municipality may further restrict smoking
11 within the boundaries of any public beaches and public parks within its jurisdiction, unless such restriction
12 conflicts with a county ordinance, except that the municipality may not further restrict the smoking of
13 unfiltered cigars; and

14
15 **WHEREAS**, cigarette butts pollute parks and waterways and contain toxic chemicals that adversely impact
16 the environment; and

17
18 **WHEREAS**, littered cigarette butts and filtered cigar debris are difficult to remove from public parks, can
19 cause hazards to park patrons and wildlife, can significantly detract from a healthy environment, and can
20 reduce the enjoyment of the City's public parks for those individuals and families who want to enjoy a
21 healthy environment, free of smoking-related pollution and hazards; and

22
23 **WHEREAS**, the City Commission desires to regulate smoking at parking parks in accordance with its
24 statutory authority; and

25
26 **WHEREAS**, the City Commission desires a delayed effective date to allow for public education on this new
27 regulation; and

28
29 **WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare
30 of the citizens of the City of North Port, Florida.

31
32 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

33 **SECTION 1 – FINDINGS**

36 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.

37 1.02 In accordance with Florida Statutes Section 166.041(4)(a), the City timely posted a business
38 impact estimate on the City’s website on or before the date the newspaper published notice of
39 this ordinance’s final reading.

41 **SECTION 2 – ADOPTION**

42
43 2.01 Chapter 46 of the Code of the City of North Port, Florida is hereby amended as follows:
44

45 **“Chapter 46 – OFFENSES**

46 . . .

47 **ARTICLE III. – OFFENSES INVOLVING PUBLIC SAFETY**

48 . . .

49 **Sec. 46-64. – Smoking prohibited in parks.**

50
51 (a) Prohibited conduct. Smoking cigarettes, e-cigarettes, vapes, filtered cigars, pipes, and other
52 devices that can be used to inhale, exhale, burn, or carry tobacco products are prohibited at
53 the city’s public parks identified below, except in designated smoking areas. This prohibition
54 does not apply to unfiltered cigars.

56 (b) Designated smoking areas. A designated smoking area may only be located on an improved
57 parking lot that is paved, shelled, or graveled; it may not be located on grass or any other
58 unimproved parking area. A park that does not have the proper type of improved parking area
59 will not have a designated smoking area. Designated smoking areas must be identified with
60 signage and waste receptacles.

62 (c) Park locations. This regulation applies to the following public parks:

89 (d) Enforcement. A person issued a violation shall have thirty (30) days from the date of issuance
 90 to pay the applicable penalty or request a hearing before the city’s hearing officer to contest
 91 the violation. A person’s failure to pay the applicable penalty or request a hearing within the
 92 time provided by this section shall be deemed an admission of the violation and shall
 93 constitute a waiver of any right to contest the violation.

94

95 (e) Penalties. The penalty imposed pursuant to this section shall be \$25.00 for a first violation,
 96 \$50.00 for a second violation, and \$75.00 for each additional repeat violation.”

SECTION 4 – CONFLICTS

4.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

SECTION 5 – SEVERABILITY

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 6 – CODIFICATION

6.01 In this ordinance, additions are shown as underlined and deletions as ~~striketrough~~. Any additional codification information and notations appear in *italics*. These editorial notations are not intended to appear in the codified text.

SECTION 7 – EFFECTIVE DATE

7.01 This ordinance takes effect on March 1, 2024.
