1. JOINT DISCUSSION ITEMS:

A. <u>23-0859</u> 2017-2022 County Actions on Affordable Housing Update (Sarasota County)

Mr. Oysterheart, provided a presentation to include challenges, how it affects workforce talent, understanding your community, solutions and strategies, setting the foundation, affordable housing strategies, tool box implementation, surplus lands, third party analysis, surplus land examples, targeted funding, American Rescue Plan Act (ARPA), reduced fees/processing time, density bonus, development standards, half dwelling units, and strategic action plan.

Commission questions and discussion took place regarding surplus lands and ARPA funds.

B. <u>23-0860</u> Growth Patterns in North Port Update (North Port)

Ms. Ray provided a presentation to include growth patterns and annual population estimate per Bureau of Economic and Business Research (BEBR).

C. <u>23-0861</u> Mobility System Update (Sarasota County)

Ms. Grogg provided a presentation to include Ridership by Route 2018, cost per passenger by Route 2018, new mobility system, mobility system update, most frequent OnDemand destinations, Breeze Rider app real-time location and going forward.

Commission questions and discussion took place regarding recognition for presentation, OnDemand service, Sarasota County Area Transit (SCAT) to Breeze, OnDemand routes, Legacy Trail bike route, Wellen Park route, tracking repeat riders, and North Port High School utilization.

D. 23-0862 Aquatic Center Update (North Port)

Ms. Pfundheller provided a presentation to include Aquatic Center highlights.

Commission questions and discussion took place regarding enjoyable amenities, price differences from City and County rates, partnership with the county, lifeguard responsibilities, Aquatic Center promotion, new activities, revenues and expenses, advertisement, swimming sport program and participation.

E. <u>23-0863</u> Mosquito Management Update (Sarasota County)

Mr. Brennan, provided a presentation to include mission, history, integrated pest management program, being science driven, advanced technology, environmental focus, efficiency driven, field technicians, mission planning for mosquito surveillance, precision target location, monitor contractor, county percentage of service request, ditch acres and ariel and truck treatments, new facility, and premier organization.

Commission questions and discussion took place regarding tour of the facility, new employee for North Port, task force recommendations and updated study, community education, pesticide application, gambusia uses, customer satisfaction, spraying location responsibilities (Myakka and State Forest), and pesticide traps and pods distribution.

F. 23-0864 Southern Interchange Update (North Port)

Ms. Ray provided a presentation to include long term project and highlights and provided a map.

Commission questions and discussion took place regarding support made by resolution.
