At Thanksgiving time, our Women's Ministry will coordinate a community effort to ensure families have what they need for a complete holiday meal. Members of our congregation donate non-perishable food items such as canned vegetables and stuffing. We then provide each family with a gift card specifically intended for purchasing perishable items like a turkey, bread, and other essentials needed to complete their meal. This allows families to prepare and enjoy a full Thanksgiving dinner in their own homes. At Christmas, we focus on North Port families with children who are in need. Through referrals and community connections, we select families who are facing financial hardship and help them purchase Christmas presents for their children. This outreach provides both practical support and a sense of joy during what can otherwise be a difficult season.

Please describe what data or statistics will be utilized to measure the impact:	We will measure impact by tracking the number of North Port families who receive Thanksgiving assistance, as well as the number of families with children who receive Christmas gift assistance.

In detail, how will this item assist the North Port community?	This space is used to plan and coordinate outreach events, host leadership and ministry meetings, and conduct free counseling sessions for community members in need, including marriage counseling, family counseling, and life coaching. We also use this room for small groups, mentoring, and ministry team gatherings. It is important that the Conference Room is a welcoming, comfortable, and safe environment for both our congregation and the community. The primary Conference Room plays a central role in preparing for outreach ministries such as our Thanksgiving and Christmas efforts. Each Thanksgiving, our Women's Ministry organizes meal packages and gift cards for North Port families in need. At Christmas, we partner with the community to provide gifts for children from families experiencing hardship. These programs require extensive planning and coordination - much of which takes place in this very space. The church will cover the remaining cost for the conference table, chairs, and a TV screen to be used for teaching, counseling, and meeting purposes. With NP ² Program support, we can better equip this vital space to continue serving as a hub for planning, connecting, and caring for the people of North Port.
Please describe the expected impact:	Since moving into our current location, our church family has grown significantly, averaging over 600 people in weekly attendance. Each week, more than 100 children meet here for engaging, Christ-centered programs that help them grow in character, relationships, and faith. This doesn't include the people that will be impacted in the community outside our walls!
Please describe what data or statistics will be utilized to measure the impact:	We will measure impact by tracking the number of meetings, counseling sessions, small groups, and outreach planning events held in the primary Conference Room. Records will include the type of activity (such as marriage counseling, family counseling, ministry meetings, or community outreach planning), the number of participants served, and the frequency of use. The space will be used daily by our staff and weekly by our congregation, ensuring consistent benefit to both our church family and the broader North Port community throughout the year.
Is your impact reliant on a partnership with an external agency?	No, but this funding will certainly help!

ARTICLES OF INCORPORATION

OF

FREEDOM BIBLE CHURCH, Inc.

We, the undersigned, with other persons being desirous of forming a corporation for religious purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

NAME

The name of this corporation is FREEDOM BIBLE CHURCH, INC.

ARTICLE II.

PURPOSES

Section 1. These Article of Incorporation may be amended at a special meeting of the Elders called for that purpose by a majority vote of those present.





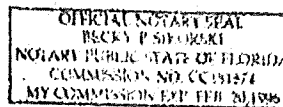
