### **RESOLUTION NO. 2024-R-03**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AS THE GOVERNING BODY OF THE NORTH PORT ROAD AND DRAINAGE DISTRICT, REPEALING AND REPLACING RESOLUTION NO. 2024-R-61, ESTABLISHING A SCHEDULE AND LOCATION OF ROAD AND DRAINAGE DISTRICT REGULAR MEETINGS FOR THE 2025 CALENDAR YEAR; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the North Port Road and Drainage District ("District") is a dependent special district; and

**WHEREAS**, pursuant to Section 66-51 of the Code of the City of North Port, Florida, the City Commission of the City of North Port, Florida, serves as the governing body of the District (the "Board"); and

**WHEREAS**, the Board has the powers granted by the Code of the City of North Port, Florida ("City Code"); the City Charter; the general laws of the State of Florida; and the City's home rule authority, as may be necessary or proper to carry out the intent and purpose of the District; and

**WHEREAS**, pursuant to Section 66-60 of the City Code and Florida Statutes Section 189.015, the District's governing body shall file with the City Clerk the schedule of the District's regular meetings, including the date, time, and location of each scheduled meeting.

**WHEREAS**, on November 26, 2024, the City Commission adopted Resolution No. 2024-R-61, establishing a schedule and location of Road and Drainage District regular meetings; and

**WHEREAS**, the City Commission desires to repeal Resolution No. 2024-R-61 and replace it with Resolution No. 2025-R-03.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SERVING AS THE GOVERNING BODY OF THE NORTH PORT ROAD AND DRAINAGE DISTRICT:

SECTION 1 – FINDINGS

1.01 The above recitals are ratified and confirmed as being true and correct and are incorporated in this resolution as findings of the governing body.

deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

#### **SECTION 5 – EFFECTIVE DATE**

5.01 This resolution takes effect immediately.
