Section I: The solicitation was broadcast to 1,139 suppliers plus 745 supplemental suppliers. Bid opening was held on August 27, 2025, five (5) bids were received and reviewed for responsiveness. The results of the due diligence review and tabulation are attached. Below is the bid amount from contractors that submitted:

A responsible person, company or entity is determined to have the capability in all respects to fully perform the contract requirements and has the integrity and reliability which will assure good faith performance and the capacity and capability to perform in accordance with the specifications. Additionally, verify the references as applicable (Section II B & C, below) and make sure the qualifications which were specified in the solicitation have been met. Please complete and sign this form and attach your recommendation along with the recommendation of the Department for Finance Director's approval. Upon receipt of this form, Purchasing will post Notice of Intent (NOI) and you may initiate the contract process.
