<p>Body Worn Camera Used</p> <p>NARRATIVE</p> <p>On July 13, 2025, at approximately 12:15 PM, I responded to a report of a disturbance at Warm Mineral Springs Park, located at 12200 San Servando Avenue in North Port, Florida.</p> <p>Upon my arrival, I learned from the complainant that an individual named Oleg Boyarkin was causing a disruption by removing his clothing in public. This behavior not only attracted attention but also led to confrontations with the park staff. Mr. Boyarkin's actions created significant discomfort for all citizens present in the vicinity and further escalated tensions among the staff members involved.</p> <p>To address this situation appropriately, we engaged an interpreter from Propio Services (ID: 52074) to communicate effectively with Mr. Boyarkin.
