#### ORDER FOR COMPLIANCE NOTICE OF HEARING TO ASSESS ADMINISTRATIVE FINE

**AFTER DUE NOTICE** to Respondent(s), the HEARING OFFICER OF THE CITY OF NORTH PORT heard testimony and took evidence concerning the above-styled cause at a public hearing on January 26, 2023. Based upon the testimony heard and the evidence presented, the HEARING OFFICER established the following FINDINGS OF FACT in this cause:

- 1. Respondent(s), Luba Prokosa, own(s) the property commonly known as, 6093 Fabian Rd North Port, Sarasota County, Florida (LOT 6 BLK 1981 42ND ADD TO PORT CHARLOTTE, a subdivision according to Plat thereof, of the Public Records of Sarasota County, Florida).
- 2. Code Enforcement Inspector HENLEY LEE BURTON served the Respondent(s) a NOTICE OF VIOLATION, dated June 16, 2022.
- 3. The Respondent did not comply with the NOTICE OF VIOLATION within the time frame set forth therein.

# Based upon the foregoing FINDINGS OF FACT, the HEARING OFFICER finds the following CONCLUSION(s) OF LAW:

4. Respondent's actions constitute a violation of:

Chapter 105.1, Florida Building Code - Permit required.

(Above ground pool in rear of property, as well as shed, and pergola with no permit on file for any of them.) <u>Section 42-24(a)(2)(b) North Port City Code, Maintenance of stormwater drainage area.</u> (Three (3) New Palm trees planted in City Right-of-way of which cannot be there.)

# Based upon the FINDINGS OF FACT and CONCLUSION(s) OF LAW, and upon consideration, it is thereupon

#### **ORDERED** that:

5. Respondents(s) shall correct the violation(s) by promptly Obtain required permit(s); Remove the 3 new palm trees planted in the City Right of way.

- 6. If Respondent(s) fail(s) to correct the violation(s) by May 6th, 2023, RESPONDENT MAY BE ASSESSED THE SUM OF \$10.00 per day for Building Code Violation & \$10.00 per day for City Code Violation, beginning May 7th, 2023, which shall continue to accrue daily until the property is brought into compliance as set forth in Paragraph 5 AND SUCH COMPLIANCE IS CONFIRMED IN ACCORDANCE WITH Ordinance NO. 2015-26 Section 2-511 (C), Code of the City of North Port, or until the Maximum Cumulative Fine of \$5,000.00 for Building Code Violation, & \$1,000.00 for Building Code Violation, has been reached.
- 7. Respondent(s) shall attend a hearing before the HEARING OFFICER scheduled for *May 25th, at 9:00 a.m.* or as soon thereafter as possible, in **City Chambers**, City Hall, 4970 City Hall Boulevard, North Port, Florida for the purpose of determining whether the stated administrative fine should be assessed for failure to comply with this Order for Compliance.
- 8. A certified copy of an ORDER ASSESSING ADMINISTRATIVE FINE imposing the above stated fine may be recorded in the Public Records of Sarasota County, Florida by the City Clerk of the City of North Port and shall constitute a lien upon the real property on which the violations(s) exists and upon the real or personal property owned by the violator(s) consistent with Chapter 162, Florida Statutes, and Chapter 2, North Port City code, for which let execution issue.
- 9. THE HEARING OFFICER retains jurisdiction in all respects to enforce its prior order(s) requiring compliance and to issue such orders having the force of law to command whatever steps are necessary to bring continued violation(s) into compliance.

As soon as compliance is achieved, Respondent(s) shall notify the Code Enforcement Division IN WRITING to request a re-inspection using the "Request for Re-inspection" form that is attached to this Order. Respondent shall provide the completed form to:

Pursuant to the attached AFFIDAVIT OF POSTING dated *December 07, 2022, YOU ARE HEREBY FORMALLY NOTIFIED* that at *9:00 a.m.,* or as soon thereafter as possible, *on January 26, 2023,* in City Chambers, City Hall, *4970 City Hall Boulevard, North Port, Florida,* there will be a public hearing to determine whether or not you have violated certain CITY OF NORTH PORT, FLORIDA CODES/ORDINANCES with regard to the CODE OF THE CITY OF NORTH PORT, FLORIDA. A NOTICE OF VIOLATION, dated *June 16, 2022,* was previously served by *REGULAR MAIL.* 

The attached **AFFIDAVIT OF POSTING** specifying the Code Provisions violated and the facts and circumstances of the CODE VIOLATION have been filed with the CITY OF NORTH PORT, CITY CLERK.

**YOU ARE HEREBY ORDERED** to appear before the HEARING OFFICER of the CITY OF NORTH PORT, FLORIDA on *January 26, 2023*, to present your case with regard to the violation stated in the attached AFFIDAVIT OF VIOLATION.

In exercising their power under CHAPTER 162, FLORIDA STATUTES, and CHAPTER 2, ARTICLE IX, CODE ENFORCEMENT, CITY OF NORTH PORT finds a violation exists, it shall:

- (a) Order the violator to pay administrative fine in amount consistent with Section 2-511, Code of the City of North Port, for each day the violation(s) exists beyond the date set for compliance by the HEARING OFFICER. If the violation(s) is a repeat violation occurring within the last five (5) years, administrative fine(s) may be imposed, for each day the repeat violation continues, beginning with the date the repeat violation is found to have occurred by the Property Standard Inspector;
- (b) Order the violator to pay a fine not to exceed \$1,000.00, \$2,000.00, \$5,000.00, or \$25,000 per violation, dependent upon the violation, if the violation was irreparable or irreversible in nature. If it pertains to unsafe abatement as determined by the building Official. There is no maximum fine cap defined in 2-511(b)(1)(d); and
- (c) Issue orders having the force of law to command whatever steps necessary to bring the violation(s) into compliance.

# CONSISTENT WITH SECTION 162.09(1) FLORIDA STATUTES, NO OTHER HEARING SHALL BE NECESSARY FOR THE ISSUANCE OF THE ORDER ASSESSING THE ADMINISTRATIVE FINE(S).

In the event that the violator does not pay the administrative fine(s) (if any) prescribed by the CITY OF NORTH PORT, FLORIDA HEARING OFFICER at the hearing, the CITY OF NORTH PORT may establish a lien against the violator's property on which the violation(s) exists and upon any other real or personal property owned by the violator in accordance with Section 162.09(3), Florida Statutes and Section 2, CODE OF THE CITY OF NORTH PORT, FLORIDA. Should it become necessary for the CITY OF NORTH PORT, FLORIDA to foreclose on such a lien, the RESPONDENT(S) could be liable for additional expenses including, but not limited to, reasonable attorney fees, costs, and expenses incurred by the CITY OF NORTH PORT, FLORIDA or its agents and the same may be assessed as cost in the foreclosure action.

Although you may represent yourself, you have the right to an attorney at your own expense to represent you before the HEARING OFFICER. You have the right to record the proceedings of the hearing at your own expense. You also will have the opportunity to present witnesses as well as question the witnesses who may testify against you prior to the HEARING OFFICER making a determination. Please be prepared to present evidence at the hearing why you should not be found in violation of the Code Provision cited in the attached AFFIDAVIT OF VIOLATION and, in the case of a repeat violation, why an administrative fine(s) shall not be assessed.

A copy of the ORDER FOR COMPLIANCE and ORDER ASSESSING ADMINISTRATIVE FINE(S) shall be provided to you by Certified Mail, Return Receipt Requested, within fifteen (15) days following the date the orders are rendered.

THE CITY OF NORTH PORT MAY PROCEED IN THE ABSENCE OF ANY PARTY, THEIR AGENT, OR THEIR ATTORNEY, WHO AFTER DUE NOTICE, FAILS TO BE PRESENT AT THE HEARING.



You have been issued a Notice of Mandatory Hearing. At the scheduled hearing, the City's Hearing Officer will determine if you have violated one or more provisions of the Code of the City of North Port, the City's Unified Land Development Code, or the Florida Building Code as alleged. Please read the below information carefully regarding your rights under the law and the hearing procedure.

#### I. RIGHTS/PROCEDURES

- 1. On the day of the hearing you will be given the opportunity to present evidence showing why you should not be found in violation of the code provision(s) as alleged. You have the right to represent yourself at the hearing. You also have the right, at your own expense, to the following:
  - a. Have your own personal attorney represent you during the hearing by filing a Notice of Representation, signed by the attorney, with the City Clerk's Office at least five (5) days prior to the hearing date;
  - b. Have a non-attorney represent you during the hearing by completing the attached Designation of Power of Attorney form and filing a notarized copy with the City Clerk's Office at least five (5) days prior to the hearing date;
  - c. Record the hearing; and
  - d. Present and question your own witnesses and any witnesses testifying against you.
- 2. During the hearing, a Code Enforcement Inspector or Police Officer will present evidence of the alleged violation. You will then be given the opportunity to present your testimony, witnesses, and evidence to rebut the Code Enforcement Inspector's or Police Officer's evidence. The Hearing Officer is also permitted to ask questions of either party and/or their witnesses if desired. The hearing will be recorded, and all testimony will be taken under oath or affirmation.
- 3. Evidence submitted as an exhibit to your case, such as pictures and written statements, will become a permanent part of the case and made part of the record. Once part of the record, it is possible that these items will not be returned to you. Therefore, please bring copies of any evidence you will submit as an exhibit. Please be aware: electronic submittals, such as pictures on your phone, cannot be made a part of the record. All items included in the record must be in a hardcopy or printed format.
- 4. If you have a Code Enforcement case and the violation is corrected and then recurs, or if the violation is not corrected by the time specified for correction by the Code Enforcement Inspector, your case may still be presented before the Hearing Officer, even if the violation has been corrected prior to the hearing date.

<u>Note</u>: Daily fines can run concurrently for each violation. A fine imposed by the Hearing Officer and recorded with the Clerk of the Circuit Court, shall accrue to the maximum of each violation until the violation comes into compliance and such compliance is confirmed, or the maximum cumulative fine has been reached.


#### LIEN(S) MAY BE PLACED:




