## RESOLUTION NO. 2023-R-48

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET AND CAPITAL IMPROVEMENT BUDGET FOR FISCAL YEAR 2022-2023 FOR LAW ENFORCEMENT EQUIPMENT, SANS REPLACEMENT PROJECT IT22SR, ONE ADDITIONAL FULL TIME EQUIVALENT IN UTILITIES, HURRICANE IAN COSTS, PARKS AMENITIES PROJECT P23PAI, COSTS FOR INCREASE IN SERGEANT AND POLICE OFFICER COMPENSATION, AND PAYMENT RELATED TO THE WEST VILLAGES DEVELOPER AGREEMENT POST ANNEXATION IN THE AMOUNT OF \$3,327,485; PROVIDING FOR FINDINGS; PROVIDING FOR POSTING; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, Resolution No. 2022-R-53 approved the Non-District Budget and Capital Improvement Budget for fiscal year 2022-2023; and

**WHEREAS**, Florida Statutes Section 166.241(7)(c) requires that a budget amendment be adopted in the same manner as the original budget; and

**WHEREAS**, the City Commission desires to amend the Non-District Budget and Capital Improvement Budget for supplemental appropriations.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:**

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this resolution is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

**SECTION 6 – EFFECTIVE DATE**

6.01 This resolution takes effect immediately.
