#### RESOLUTION NO. 2022-R-12

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, SUPPORTING THE CONTINUATION OF THE ONE PERCENT LOCAL GOVERNMENT INFRASTRUCTURE SURTAX AND ADOPTING THE CITY OF NORTH PORT PROJECT LIST FOR INFRASTRUCTURE SURTAX YEARS 2025 – 2039 INFRASTRUCTURE SURTAX PROCEEDS; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes Section 212.055(2) authorizes the Board of County Commissioners of Sarasota County to levy a local government infrastructure surtax of one percent throughout Sarasota County, Florida ("sales tax") subject to referendum approval; and

WHEREAS, on June 27, 1989, Sarasota County voters approved the levy of a sales tax for a period of ten years, effective September 1, 1989; and

WHEREAS, on November 4, 1997, Sarasota County voters approved the continuation of the sales tax levy for an additional ten years, effective September 1, 1999; and

WHEREAS, on November 6, 2007, Sarasota County voters approved the continuation of the sales tax levy for an additional fifteen years, effective September 1, 2009; and

WHEREAS, on November 8, 2022, Sarasota County voters will be presented with a referendum to vote on another fifteen-year continuation of the sales tax levy; and

**WHEREAS**, the City Commission recognizes the importance of the continuation of the sales tax to the quality of life in the City of North Port as everyone who visits or lives in Sarasota County contributes to the revenue generated by the surtax; and

**WHEREAS**, the City Commission finds that it is in the best interest of the citizens of the City of North Port to continue the sales tax levy for another fifteen years in order to maintain and continue acceptable levels infrastructure.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

#### SECTION 1 - INCORPORATION OF RECITALS

1.01 The above recitals are true and correct and are incorporated in this resolution by reference.

### SECTION 2 – SUPPORT FOR CONTINUATION OF INFRASTRUCTURE SALES SURTAX

2.01 The City Commission supports the continuation of the one percent Local Government Infrastructure Surtax currently levied throughout Sarasota County, Florida for an additional fifteen years subject to approval by voter referendum, commencing January 1, 2025.

#### SECTION 3 – USE OF CITY'S SHARE OF INFRASTRUCTURE SALES SURTAX

- 3.01 The City Commission adopts the City of North Port Project List for Infrastructure Surtax Years 2025 2039, attached and incorporated into this resolution as Exhibit A.
- 3.02 The City Commission finds that the best use of the City of North Port's sales tax proceeds are for financing, planning, and constructing the infrastructure identified on the project list.
- 3.03 The City Commission further finds that the infrastructure identified on the project list meets the definition of infrastructure and comply with the requirements for allocation of infrastructure surtax proceeds provided in Florida Statutes Section 212.055(2).
- 3.04 The City Commission may alter or amend the project list in the event that the City Commission finds that such a change is in the public interest and provided that all projects are consistent with the requirements of Florida Statutes Section 212.055(2).

### SECTION 4 – CONFLICTS

4.01 In the event of any conflict between the provisions of this resolution and any other resolution, in whole or in part, the provisions of this resolution will prevail to the extent of the conflict.

# **SECTION 5 - SEVERABILITY**

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this resolution is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

#### SECTION 6 – EFFECTIVE DATE

6.01 This resolution takes effect immediately.
