ORDINANCE NO. 2025-01

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, AMENDING THE NON-DISTRICT BUDGET AND CAPITAL IMPROVEMENT BUDGET FOR FISCAL YEAR 2024-2025 FOR HURRICANE IAN REPAIRS AND ADDITIONAL COSTS TO PARK IMPACT FEE PROJECTS P21VET CIRCLE OF HONOR; P17EPI ENVIRONMENTAL PARK IMPROVEMENTS; AND P24LTC LEGACY TRAIL CONNECTION TO WARM MINERAL SPRINGS IN THE AMOUNT OF \$3,171,180; PROVIDING FOR FINDINGS; PROVIDING FOR POSTING; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance No. 2024-31 approved the Non-District Budget and Capital Improvement Budget for fiscal year 2024-2025; and

WHEREAS, Florida Statutes Section 166.241(8) requires that a budget amendment be adopted in the same manner as the original budget; and

WHEREAS, the City Commission desires to amend the Non-District Budget and Capital Improvement Budget for supplemental appropriations.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 – FINDINGS

- 1.01 The above recitals are true and correct and are incorporated in this ordinance by reference.
- 1.02 Pursuant to Florida Statutes Section 166.041(4)(c), a business impact estimate was not required because this ordinance relates to the adoption of budgets or budget amendments, including revenue sources necessary to fund the budget.

SECTION 2 – ADOPTION

- 2.01 The Non-District Budget and Capital Improvement Budget for fiscal year 2024-2025 is amended and appropriated as follows:

SECTION 3 – POSTING OF BUDGET AMENDMENT

3.01 Within five days of the effective date of this ordinance, the City Manager is directed to post the budget amendment on the City’s website. Pursuant to Florida Statutes Section 166.241(9), the budget amendment must remain on the website for at least two years.

SECTION 4 – CONFLICTS

4.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

SECTION 5 – SEVERABILITY

5.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

SECTION 6 – EFFECTIVE DATE

6.01 This ordinance takes effect immediately upon adoption.
