

FIRST AMENDMENT TO THE SPEED DETECTION CAMERA SYSTEM FOR SCHOOL ZONES AGREEMENT

This *First Amendment to the Speed Detection Camera System for School Zones Agreement* ("First Amendment") is made by and between the City of North Port, Florida, a Florida Municipal Corporation with its principal place of business at 4970 City Hall Boulevard, North Port, FL 34286 ("City"), and REDSPEED FLORIDA, LLC, a Florida Limited Liability Company, with its principal place of business at 400 Eisenhower Lane North, Lombard, IL 60148, ("RedSpeed"). City and RedSpeed are sometimes individually referred to as "Party" and collectively as "Parties" in this Agreement.

RECITALS

WHEREAS, on September 23, 2025, the City of North Port, Florida ("City"), and RedSpeed Florida, LLC ("RedSpeed") entered into an Agreement by and Between the City of North Port, Florida, and RedSpeed Florida, LLC, Term Contract Agreement No. 005-24 ("Original Agreement"), relating to a Speed Detection Camera System for School Zones; and

WHEREAS, the Original Agreement and this First Amendment are based on (i.e., "piggyback" from) the City of Plantation's contract for Speed Enforcement Services (the "Prior Agreement"), which was competitively procured pursuant to Section 2-220(b) of the Plantation City Code, through a formal solicitation for the services described herein; and

WHEREAS, pursuant to Section 8.R. of the Prior Agreement, the City of North Port is exercising the Contract Utilization Clause, allowing governmental entities to access and utilize the terms, conditions, and pricing set forth in the Original Agreement; and

WHEREAS, Section 3, *Terms*, Subsection 3.1, *Scope of Services and Term*, B. *Term* of the Prior Agreement provides that "the term of this Agreement shall have an initial term of five (5) years commencing on June 25, 2024, and expiring on June 24, 2029. In addition, the City reserves the right to extend this Agreement for one (1) additional five (5)-year period, provided RedSpeed also agrees in writing to the extension upon such terms as the City and RedSpeed agree;" and

WHEREAS, revisions to Exhibit B, Certificate of Liability Insurance, were necessary; and

WHEREAS, submission of an Insurance Requirements Request Form was required; and

WHEREAS, the parties now desire to amend the terms of the Original Agreement as set forth in this First Amendment; and

NOW THEREFORE, in consideration of the mutual covenants contained herein, the sufficiency and receipt of which are acknowledged, the parties agree that the Original Agreement is amended as follows, with all other terms in the Original Agreement remaining unchanged and in full force and effect:

1. EFFECT OF AMENDMENT/EFFECTIVE DATE

- A. The parties ratify the terms and conditions of the Original Agreement not inconsistent with this First Amendment, all of which are incorporated by reference as if set forth fully herein. This First Amendment modifies the sections of the Original Agreement as identified herein. Where a section of the Original Agreement is not identified, the terms as they appear in the Original Agreement

remain and apply.

- B. All references to this "Agreement" in the Original Agreement and this First Amendment mean and include both the Original Agreement and this First Amendment.
- C. This First Amendment is effective as of the date the last party approves or executes it, as applicable, (the "Effective Date") and shall continue as otherwise provided in the Original Agreement.

1. ORIGINAL AGREEMENT SECTION 2.3 - Procurement

Section 2.3- Procurement of the Original Agreement is amended in its entirety as follows:

2.3 Procurement

This is a utilization of City of Plantation's contract for Speed Enforcement Services (the "Prior Agreement"), which was competitively procured pursuant to Plantation City Code Sec. 2- 220 (b) in which the City of Plantation sought formal competitive bids/proposals for the Services mentioned herein.

The City of Plantation competitive procurement process concluded that RedSpeed was the most advantageous firm to the City taking into consideration the evaluation factors and criteria set forth in the RFSP and successful negotiations.

The City of Plantation procurement procedures, which included public posting of the RFP, evaluation by Selection Committee and approval by council are similar to the City of North Port's procedures.

2. ORIGINAL AGREEMENT SECTION 4. – TERMS.

Section 4 of the Original Agreement is amended in its entirety as follows:

4.1 TERMS

4.1 Scope of Services and Term

- A. General Scope of Services. RedSpeed shall furnish a turnkey solution for "Speed Photo Enforcement System" (herein "SPE System") to the City wherein all reasonably necessary elements required to implement and operate the solution are the responsibility of RedSpeed, as further defined in this Agreement ("Services"). The Services are more specifically described in **Exhibit A** attached hereto and incorporated herein by this reference. All Services shall be subject to, and performed in accordance with, this Agreement, the exhibits attached hereto, and all applicable local, state and federal laws, rules, and regulations. RedSpeed acknowledges that the City may enter into agreements with other firms for services similar to the Services that are the subject of this Agreement or may have its own employees perform services similar to the Services.
- B. Term. The term of this Agreement shall have an initial term commencing on the date the Agreement is signed by both parties and expiring on June 24, 2029.
