#### **ORDINANCE NO. 2024-20**

AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, REPEALING SECTION 34-1 OF
THE CODE OF THE CITY OF NORTH PORT, FLORIDA, RELATING TO MOBILE FOOD
VENDORS; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICTS; PROVIDING FOR
SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, on August 6, 2024, the City Commission adopted Ordinance No. 2024-13, providing for the repeal of Unified Land Development Code (ULDC), Chapters 1, 5, 9, 13, 14, 17, 18, 21, 25, 28, 33, 37, 41, 45, 49, 53, 55, 57, 58, 59, 60, and 61, and replacement of those chapters with Chapters 1 through 4 and 6, and Appendices; and

**WHEREAS**, processes and regulations related to mobile food vendors, currently located in Section 34-1 of the Code of the City of North Port, Florida, appear in the newly adopted Unified Land Development Code; and

**WHEREAS**, the City Commission finds that these amendments serve the public health, safety, and welfare of the citizens of the City of North Port, Florida.

#### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:
