Proprietary materials of either Party are for use between the Parties only and each Party shall take all reasonable precautions to prevent third parties from viewing, recording, or copying a Party's proprietary materials and these materials shall not be modified by anyone other than the Agency or Encoretech.

Delays or Termination

The Agency will provide Encoretech with at least ten business days' notice of cancellation or rescheduling of any Services or the Agency will be billed the full rate. Notice shall be provided in writing, but email is acceptable if Encoretech confirms receipt. The City Manager is authorized to terminate on behalf of the Agency.





Expiration of this Statement of Work:




