RESOLUTION NO. 2025-R-33

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA, IDENTIFYING AN INVENTORY LIST OF CITY-OWNED REAL PROPERTY SITES THAT ARE APPROPRIATE FOR USE AS AFFORDABLE HOUSING; PROVIDING FOR INCORPORATION OF RECITALS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida Statutes Section 166.0451, requires that by October 1, 2023, and every three years thereafter, each municipality shall prepare and adopt by resolution an inventory list of all property within its jurisdiction that it or any dependent special district within its boundaries holds in fee simple title and that is appropriate for use as affordable housing; and

WHEREAS, Florida Statutes Section 166.0451, further requires the governing body of the municipality to review the inventory list at a public hearing, make revisions to the list at the conclusion of the public hearing, and following the public hearing to adopt a resolution that includes an inventory list of the properties; and

WHEREAS, the City Commission desires to identify the property currently appropriate for use as affordable housing in compliance with Florida Statutes Section 166.0451.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH PORT, FLORIDA:

SECTION 1 – INCORPORATION OF RECITALS

1.01 The above recitals are true and correct and are incorporated in this resolution by reference.

SECTION 2 – INVENTORY LIST OF PROPERTY APPROPRIATE FOR USE AS AFFORDABLE HOUSING

2.01 The City Commission hereby approves the list attached to this resolution as Exhibit A, identifying the real property within the City's jurisdiction to which the City of North Port or any dependent special district within the City's boundaries holds fee simple title and which are appropriate for use as affordable housing for the purposes described in Florida Statutes Section 166.0451(2).

2.02 All identified exhibits are incorporated in this resolution by reference.

SECTION 3 – CONFLICTS

3.01 In the event of any conflict between the provisions of this resolution and any other resolution, in whole or in part, the provisions of this resolution will prevail to the extent of the conflict.

SECTION 4 – SEVERABILITY

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this resolution is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the resolution.

SECTION 5 – EFFECTIVE DATE

5.01 This resolution takes effect immediately.
