- 1. Respondent(s), Thomas D & Angela Lambert, own(s) the property commonly known as, 6770 Flavia Ct North Port, Sarasota County, Florida (LOT 11 BLK 2056 44TH ADD TO PORT CHARLOTTE, a subdivision according to Plat thereof, of the Public Records of Sarasota County, Florida).
- 2. Code Enforcement Inspector HENLEY LEE BURTON served the Respondent(s) a NOTICE OF VIOLATION, dated January 20, 2023.
- 3. The Respondent did not comply with the NOTICE OF VIOLATION within the time frame set forth therein.
