**NARRATIVE**

On 02/13/24, at approximately 1515 hours, I was dispatched to 1602 Kramer Way (George Mullen Center) for a battery.

While in route, I went to the North Port Police Department lobby to meet with Nevaeh Grandmaison and Pauline Guarino. Nevaeh advised that she was exiting the bus today around 1500 hours and [REDACTED] punched her in the face and then attacked her while she was on the ground. Nevaeh advised via sworn statement more specifically [REDACTED] called her over after both girls got off the bus to ask her something. Nevaeh advised [REDACTED] swung on her and she ended up on the ground. [REDACTED] then grabbed her hair and continued punching her. At that point, Alexander Romeo got between both girls and broke up the fight. Pauline then took Nevaeh to NPPD lobby and notified

Officers then spoke with [REDACTED] and she advised via sworn statement that they both agreed to fight after getting off the bus. [REDACTED] stated they got off the bus and Nevaeh threw her hands up in the air as if to say let's go and [REDACTED] thought she had swung at her first, so she punched Nevaeh.

[REDACTED] advised they both continued fighting on the ground until Alexander broke up the fight.

[REDACTED] also explained that Nevaeh has been threatening to shoot her and posting/showing pictures to her holding guns in prior week's/months.

Officers were able to [REDACTED] at the Mullen Center which depicted the two juveniles get off the bus [REDACTED] is waiting at the exit and Nevaeh walks up to her and raises her arms above her head. Immediately after, [REDACTED] punches her in the face and they both continue fighting to the ground until Alexander interjects. Officer Chan spoke with Aliyah Toribio/ witness, and she advised via sworn statement that both juveniles were arguing on the bus and talking of fighting. Aliyah advised they all got off and both started fighting until Alexander broke up the fight.

Officers observed [REDACTED] with a red mark on her neck and Nevaeh had a red mark on left cheek on her face. Photos were taken and uploaded to Evidence.com.

I provided Marsy's law via a telephone call to Arlene Fitch, Nevaeh's guardian, and she did not want the physical brochure. Eight (8) photos and two (2) videos were uploaded to Evidence.com. All parties denied any medical treatment for injuries. Both parent, guardian was apprised of the incident. [REDACTED] qualified for a juvenile citation for violation of F.S.S 784.03 (1)(a)(1) battery; touch or strike. I found she was the primary aggressor due to [REDACTED] her strike Nevaeh first. [REDACTED] was also trespassed from the Mullen Center for year pending the 10-day appeal process due to being a government building.

This crime occurred in North Port, Sarasota County, FL.
