ORDINANCE NO. 2024-01

1AN ORDINANCE OF THE CITY OF NORTH PORT, FLORIDA, ADOPTING CERTAIN2STANDARDS OF THE INTERNATIONAL PROPERTY MAINTENANCE CODE RELATED TO THE3EXTERIOR MAINTENANCE OF NON-RESIDENTIAL PROPERTIES, BUILDINGS, AND4STRUCTURES; AMENDING THE CODE OF THE CITY OF NORTH PORT, FLORIDA, CHAPTER542, ARTICLE V, SECTIONS 42-84 THROUGH 42-86; PROVIDING FOR FINDINGS;6PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR7CODIFICATION; AND PROVIDING AN EFFECTIVE DATE.

9 WHEREAS, ensuring the exterior of non-residential properties, buildings, and structures are maintained
 10 to certain minimum standards helps to reduce blight, maintain property values, and enhance the quality
 11 of life for City residents and businesses; and

WHEREAS, the International Property Maintenance Code, published by the International Code Council,
 serves as a national model code of minimum standards for the maintenance of properties, buildings, and
 structures; and

- WHEREAS, Chapter 3 of the International Property Maintenance Code is broad in scope and includes a
  variety of requirements for the maintenance of exterior property areas and elements of structures
  - variety of requirements for the maintenance of exterior property areas and elements of structures intended to maintain a minimum level of safety and sanitation for both the general public and the occupants of structures, and to maintain building structural and weather-resistance performance; and
  - WHEREAS, Chapter 3 of the International Property Maintenance Code contains criteria for the maintenance of building components, vacant structures and land, the safety, sanitation, and appearance of the exterior of structures and all exterior property areas, accessory structures, vehicle storage, and owner/occupant responsibilities; and

    Maintenance Code serves the public health, safety, and welfare of the citizens of the City of North Port,

52 53		ensuring adequate maintenance of the exterior of non-residential properties, buildings, and

57		(a) Sections 301, 302, 304, 308, and 309 of the International Property Maintenance Code, 2021
58		edition, including all appendices and amendments, revisions, and/or recodifications thereto
59		as may be hereafter promulgated by the International Code Council, for regulating and
60		governing the conditions and maintenance of existing non-residential properties, buildings,
61		and structures are hereby adopted and incorporated by reference into this Code as if fully
62		codified herein, with the insertions and deletions prescribed in this section. The identified
63		sections of the International Property Maintenance Code adopted herein shall be maintained
64		on file in the office of the department responsible for land development in the City of North
65		<u>Port.</u>

75		Where the identified sections of the International Property Maintenance Code adopted in this
76		article conflict with specific provisions of this Code or the City of North Port Unified Land
77		Development Code (ULDC), as amended, the specific provisions of this Code and/or the ULDC shall
78		control."

- SECTION 3 CONFLICTS
- 3.01 In the event of any conflict between the provisions of this ordinance and any other ordinance, in whole or in part, the provisions of this ordinance will prevail to the extent of the conflict.

#### **SECTION 4 – SEVERABILITY**

4.01 If a court of competent jurisdiction finds that any section, subsection, sentence, clause, phrase, or provision of this ordinance is for any reason invalid or unconstitutional, that provision will be deemed a separate, distinct, and independent provision and will not affect the validity of the remaining portions of the ordinance.

5.01 In this ordinance, additions are shown as <u>underlined</u> and deletions as <del>strikethrough</del>. Any additional codification information and notations appear in *italics*. These editorial notations are not intended to appear in the codified text.

### SECTION 6 – EFFECTIVE DATE

6.01 This ordinance takes effect immediately upon adoption.
